RESOLUTION NO. 2018-029

A RESOLUTION EARNESTLY ENDORSING FOR FUNDING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) LOCAL GOVERNMENT SUPPORT FUND-UNDER ITS FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA TO LGUS) THE PROJECT ASSISTANCE TO INDIGENT PATIENTS EITHER CONFINED OR OUTPATIENTS IN THE TOTAL AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00) WHICH IS
INCLUDED IN THE LIST OF PRIORITY PROJECTS OF THE CITY, AND AFFIRMING THAT SUCH PROPOSED PROJECT FOR FUNDING IS PART OF THE DULY APPROVED CY 2017 ANNUML INVESTMENT PROGRAM OF THE CITY.

WHEREAS, the Fourteenth Sangguniang Panlungsod received an urgent Endorsement from the Office of the City Mayor dated January 29, 2018 requesting for the issuance of a Resolution stating a specification of the list of priority projects in the total of ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00) covering Health (Assistance to indigent patients either confined or outpatient including professional fees) and endorsing the same along with affirming that the said project for funding is part of the duly approved Annual Investment Program (AIP) of the city, further classifying the same as EXTREMELY URGENT;

WHEREAS, through a Resolution passed by the City Development Council, particularly CDC Resolution No. 3 Series of 2016, the Annual Investment Plan (AIP) for CY 2017 was approved;

WHEREAS, the requested resolution is pursuant to the requirements set under Item No. 3.0 of the Local Budget Circular (LBC) No. 114 dated March 6, 2017which subject is the "Guidelines on the Release and Utilization of the FY 2017 Local Government Support- Fund Financial Assistance to Local Government Units (LGSF-FA to LGUs)";

WHEREAS, a specification of the list of priority projects in the total amount of ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP 1,500,000.00) includes the following, to wit:

Health (Assistance to indigent patients either confined or outpatient including professional fees)

WHEREAS, the abovementioned priority project/program for funding is part of the duly approved AIP 2017 of the City and this Sanggunian fully supports the City Mayor's intention of endorsing said priority project/program for funding coverage under the LGSF-FA program;

WHEREAS, LGSF-FA to LGUs serves as the National Government's response to the various challenges faced by the LGUs in the exercise of their devolved service delivery functions foremost of which is the raising of sufficient funds for local development;

WHEREAS, LGSF was included in the FY 2017 General Appropriations Act to cover, among others, financial assistance to LGUs as support for its priority programs and projects;

WHEREAS, the program for the "Hospitalization Program for Indigent Patients" is under the City Health Office with Reference Code No. 3000-200-12 under the approved AIP CY 2017 of the City:

WHEREAS, upon close and thorough review, this Sanggunian, finds that the request is beneficial as it is anchored to the present needs of Ormocanons and deemed vital in moving forward towards the envisioned growth and development of the City in the delivery of basic health services which at all times should be made available especially to its indigent constituents and so therefore, most deserving of this august Body's full support, endorsement and affirmative action to the same;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Vice Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Rolando M. Villasencio, Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, Nolito M. Quilang and John Eulalio Nepomuceno O. Aparis II; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION EARNESTLY ENDORSING FOR FUNDING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) UNDER ITS LOCAL GOVERNMENT SUPPORT FUND-FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA TO LGUS) THE PROJECT ASSISTANCE TO INDIGENT PATIENTS EITHER CONFINED OR OUTPATIENTS IN THE TOTAL AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP 1,500,000.00) WHICH IS INCLUDED IN THE LIST OF PRIORITY PROJECTS OF THE CITY AND AFFIRMING THAT SUCH PROPOSED PROJECT FOR FUNDING IS PART OF THE DULY APPROVED CY 2017 ANNUAL INVESTMENT PROGRAM OF THE CITY;
