

**A RESOLUTION APPROVING THE PURCHASE OF ONE (1)
UNIT BRAND NEW SERVICE VEHICLE FOR THE
INTEGRATED POPULATION GENDER AND DEVELOPMENT
OFFICE (IPGDO) USE.**

WHEREAS, an Indorsement dated January 25, 2018 from the City Mayor Richard I. Gomez was received by this august Body relative to the request of Mr. Vitaliano U. Gallo, Jr., City Population Officer Designate, for the passage of a resolution approving the purchase of One (1) unit brand new Service Vehicle to be used by the Integrated Population Gender and Development Office (IPGDO) in its day to day operations;

WHEREAS, the IPGDO is a newly created office of LGU-Ormoc mandated to implement a comprehensive policy on population and development for the betterment of the quality of life of Ormocanon people;

WHEREAS, in view of the complex functions entrusted to IPGDO, the procurement of new service vehicle is deemed vital for the effective and efficient implementation of the various programs and policies all directed towards the achievement of its mandates;

WHEREAS, the funds required for the purchase of brand new service vehicle are available as certified by the City Budget Officer, OIC-City Accountant and City Treasurer through a Certificate of Availability of Funds dated January 18, 2018 to be taken from the CY 2018 General Fund particularly from the account-Capital Outlay for Motor Vehicles of the IPGDO as authorized by the Sangguniang Panlungsod through Appropriation Ordinance No. 2018-001 enacted on December 21, 2017;

WHEREAS, this Sanggunian finds the request as reasonable and most beneficial to public service, not contrary to law, public policy and morals, therefore is most deserving of prompt favorable support;
