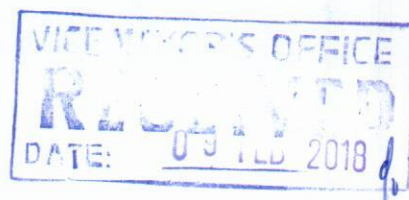

**RESOLUTION NO. 2018-032**

**A RESOLUTION APPROVING THE APPLICATION FOR  
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT  
OF ORMOC OF SABANG BAO, LABRADOR, SAN JOSE  
FARMERS ASSOCIATION (SALASAFA) IN ACCORDANCE  
WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED  
OCTOBER 16, 2014.**

WHEREAS, this Sanggunian received the application of Sabang Bao, Labrador, San Jose Farmers Association (SALASAFA), a Civil Society Organization (CSO) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, SALASAFA is composed of farmers from different barangays who are willing to participate in local good governance along with its intention to avail of any form of livelihood assistance from National Government Agencies and Non-Government Organization to establish mutual aid and protection to its members;

WHEREAS, SALASAFA is registered under the Department of Labor and Employment (DOLE) and among its purposes of organization are to assist members who are agrarian reform beneficiaries in acquiring the land awarded to them and claim support services through Agrarian Reform Programs of the government as well as to the tenant farmer members in acquiring security of tenure of the land they till;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;



WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned application, finds that the same is in order, and the purpose of the sought accreditation is for the abovementioned organization to move forward its noble intention to promote moral, social and economic development among its members through the establishment of a strong linkage with the LGU in order for the association to have a better access to future agricultural programs of the government that are beneficial to its members;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Rolando M. Villasencio, Vincent L. Rama, Tomas R. Serafica, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it


