RESOLUTION NO. 2018-037

A RESOLUTION AFFIRMING THAT FOLLOWING THE PRIORITY PROJECTS AND/OR PROGRAMS, RESPECTIVELY: THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1,500,000.00) FOR HEALTH (ASSISTANCE TO INDIGENT PATIENTS EITHER CONFINED OR OUTPATIENT [INCLUDING PROFESSIONAL FEES]), AND THE AMOUNT OF SEVENTEEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP17,500,000.00), BROKEN DOWN AS FOLLOWS: MILLION FIVE HUNDRED THOUSAND PESOS (PMP7,500,000,00) FOR HEALTH (ASSISTANCE INDIGENT PATIENTS EITHER CONFINED OR OUTPATIENT TINCL UDING PROFESSIONAL FEES]); FIVE **MILLION** PESOS (PHP5,000,000.00) SOCIAL **FOR** SERVICE (EDUCATIONAL ASSISTANCE); AND FIVE MILLION PESOS (PHP5,000,000.00) FOR CONSTRUCTION, ET. AL. OF (OPEN AND CLOSED) SPORTS FACILITIES, BUT NOT NCLUDING SPORTS EQUIPMENT, ARE PART OF THE APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) CY 2017-2020 OF THE CITY.

WHEREAS, the City Mayor Richard I. Gomez through an endorsement letter dated February 2, 2018, forwarded to this august Body for the issuance of a Resolution stating that the following priority projects are part of the 2017-2020 Ormoc City Local Development Investment Program (LDIP), to wit: the total amount of ONE MILLION FIVE HUNDRED THOUSAND PESOS (Php1,500,000.00) covering Health (Assistance to indigent patients either confined or outpatient, including professional fees; and the amount of SEVENTEEN MILLION FIVE HUNDRED THOUSAND PESOS (Php17,500,000.00), broken down as follows: for Health (Assistance to indigent patients either confined or outpatient, including professional fees) - Php7,500,000.00; Social Service (Educational Assistance) - Php5,000,000.00; and Construction, et al. (open and closed) Sports Facilities but not including Sports Equipment - Php5,000,000.00;

WHEREAS, the City Planning and Development Office (CPDO) had prepared the City's LDIP CY 2017-2020;

WHEREAS, the preparation of the LDIP is one of the basis for the budget document in the Department of Budget and Management's (DBM) Budget Operations Manual (BOM) as provided for by Local Budget Circular (LBC) No. 112 dated June 20, 2016 pursuant to Section 354 of Republic Act (RA) No. 7160;

WHEREAS, the Sangguniang Panlungsod ng Ormoc (SP) thru SP Resolution No. 2018-036 dated February 08, 2018 has just adopted and approved the said City's LDIP 2017-2020;

WHEREAS, upon examination of the adopted and approved City's LDIP CY 2017-2020 , it is observed and, therefore affirmed, that the following priority projects of the City are included in said LDIP, to wit;

A.1. Health (Assistance to indigent patients either confined or outpatient Including professional fees)
