**RESOLUTION NO. 2018-038**

**A RESOLUTION APPROVING THE APPLICATION FOR  
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT  
OF ORMOC OF CCF DREAMLAND VILLAGE HOMEOWNERS  
ASSOCIATION, INC. IN ACCORDANCE WITH THE  
PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER  
16, 2014.**

WHEREAS, this Sanggunian was in receipt of the application of CCF Dreamland Village Homeowners Association, Inc., a Civil Society Organization (CSO) seeking for accreditation with the Local Government Unit of Ormoc;

WHEREAS, CCF DREAMLAND VILLAGE HOMEOWNER'S ASSOCIATION, INC. is legitimate urban poor organization composed of residents from Brgy. Isidro and accredited with the Philippine Commission for Urban Poor (PCUP);

WHEREAS, the members of CCF Dreamland Village Homeowners Association, Inc. are recipients of the lot and housing program of Hayag Family Development Center (HFDC), a known non-government organization that facilitates the purchase of land for the homeless CCF member families;

WHEREAS, among its purpose of association is to promote, enhance and foster the development and improvement of the quality of life of the members through livelihood projects and other economic activities as well as to support the programs and services of LGU-Ormoc;



WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned application finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to establish a strong linkage with the LGU and actively participate in the implementation of the diverse programs and projects of the government to promote inclusive growth;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Vincent L. Rama, Mario M. Rodriguez, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Mariano Y. Corro and Gregorio G. Yrastorza III; be it
