**A RESOLUTION CONGRATULATING THE DEPARTMENT OF
EDUCATION (DEPED) ORMOC CITY DIVISION DELEGATION
FOR WINNING THE OVER-ALL CHAMPIONSHIP OF THE
2018 EASTERN VISAYAS REGIONAL ATHLETIC
ASSOCIATION (EVRAA) MEET HELD IN CALBAYOG CITY
AND GRANTING INCENTIVES TO THE ATHLETES AND
COACHES MEDAL WINNERS.**

WHEREAS, this august Body was in receipt of an extremely urgent indorsement from the Office of the City Mayor of a request for an issuance of a resolution giving cash awards or incentives for the athletes and coaches to the recently concluded Eastern Visayas Regional Athletic Association Meet 2018;

WHEREAS, Section 19 (1) , Article XIV of the 1987 Philippine Constitution declares as a policy that the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self -discipline, teamwork, and excellence for the development of a health and alert citizenry;

WHEREAS, the Eastern Visayas Regional Athletic Association (EVRAA) Meet was organized in pursuance to Section 11 of the Implementing Rules and Regulations of Republic Act No. 10588, otherwise known as the Palarong Pambansa Act;

WHEREAS, the DEPED Ormoc City Division participated in the Eastern Visayas Regional Athletic Association Meet (EVRAA) conducted from February 4-9, 2018 hosted by the City of Calbayog;

WHEREAS, in the said meet, the DEPED Ormoc City Division emerged triumphant as the Over-All Champion, resulting in One Hundred Nine (109) Gold, Fifty Six (56) Silver and Seventy Four (74) Bronze Medals among the thirteen (13) delegations;

WHEREAS, said victorious outcome is a first in the history of the DEPED Ormoc City Division Delegation to Eastern Visayas Regional Athletic Association Meet which deserves a high commendation and recognition of all the personal sacrifices, determination and discipline displayed by the Athletes and Coaches in carrying the name of Ormoc to glory;

WHEREAS, the City Government of Ormoc, under the leadership of our City Mayor, Richard I. Gomez, has shown strong support, in numerous occasions, acknowledged outstanding Ormocanon athletes and coaches for their astounding accomplishments of bringing to Ormoc pride and glory by winning in local and international athletic competitions;

WHEREAS, this august Body deems it appropriate that incentives are to be given to the Athletes and Coaches medal winners in the form of the following to wit:

For Team Sports:

- a. Gold - Php 20,000.00
- b. Silver - Php18,000.00
- c. Bronze - Php15,000.00

For Individual Sports:

- a. Gold - Php 5,000.00
- b. Silver - Php 3,000.00
- c. Bronze - Php 2,000.00

For the Coaches, they shall be given Three Thousand Pesos (Php3,000.00) each.
