**A RESOLUTION CONFIRMING THE APPOINTMENT OF DR.
JOSEPH C. CORTES AS CITY GOVERNMENT DEPARTMENT
HEAD I (CITY VETERINARIAN).**

WHEREAS, Section 454 (d) of RA 7160, otherwise known as the Local Government Code of 1991, provides that heads of departments, and offices shall be appointed by the Local Chief Executive with the concurrence of the majority of all the members of the Sangguniang Panlungsod and that the Sanggunian shall act on the appointment within fifteen (15) days from the date of its submission;

WHEREAS, the appointment of Dr. Joseph C. Cortes as City Government Department Head I (City Veterinarian) has been submitted to the Sangguniang Panlungsod for confirmation on February 6, 2018 and was referred to the Committee on Good Government on February 20, 2018;

WHEREAS, after careful examination, scrutiny and review of the qualifications, records and experiences of the appointee, the Committee on Good Government finds the appointment meritorious and therefore interposes no objection to the said appointment and endorses the matter to the plenary;

WHEREAS, the Sanggunian finding the recommendation of the Committee meritorious rules that the appointee possesses all the minimum qualifications set by law for the position and that he has none of the disqualifications under the Local Government Code or other existing laws;

ADOPTED, February 22, 2018.


