A RESCLUTION GRANTING AUTHORITY TO CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) REPRESENTED BY ITS EXECUTIVE DIRECTOR, MR. RICO S. PABLEO JR. FOR THE CONDUCT OF EVAM SUMMIT: 3 DAY BASIC MUSEOLOGY WORKSHOP.

WHEREAS, Section 22 (c) of RA 7160, otherwise known as Local Government Code provides that no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned.

WHEREAS, this august Body was in receipt of an endorsement from the Office of the City Mayor dated February 9, 2018 requesting for the passage of a resolution granting authority to City Mayor Richard I. Gomez to enter into and sign a Memorandum of Agreement (MOA) for and on behalf of the Local Government Unit of Ormoc (LGU-ORMOC) with the National Commission for Culture and the Arts (NCCA) represented by its Executive Director, Rico S. Pableo Jr. relative to the conduct of EVAM Summit: 3 Day Basic Museology Workshop, a copy of the MOA is hereto attached and made integral part hereof;

WHEREAS, pursuant to R.A. 7356, the NCAA is mandated to encourage the continuing and balanced development of a pluralistic culture by the people, conserve and promote nation's cultural heritage ensure the widest dissemination of artistic and cultural products and preserve and integrate traditional culture and its various creative expressions as a dynamic part of the national cultural mainstream;

WHEREAS, City Government of Ormoc (LGU-Ormoc) proposed a project entitled "EVAM Summit: 3 Day Basic Museology Workshop" which will be held on May 2018 duly participated by different LGUs in Eastern Visayas in coordination with Eastern Visayas Association of Museum and Leyte Heritage Society and the said proposed project was also applied for financial assistance to the NCAA;

WHEREAS, the project, as proposed was approved by the NCCA Board of Commissioners under Resolution Number 2018-040 dated December 19, 2017 supported by way of financial assistance in the amount specified in the said MOA chargeable to the Program on Strengthening Culture-Sensitive Governance and Development;

WHEREAS, in order to formalize the collaboration of NCCA and LGU-Ormoc with regard to the implementation of the said project, there is a need to execute a MOA;

This Amendment to the Memorandum of Agreement was made and executed this at the City of Manila by and between:

The NATIONAL COMMISION FOR CULTURE AND THE ARTS (NCCA), a government agency created by and pursuant to Republic Act No. 7356 dated 03 April 1992, with office address at the NCCA Building, General Luna Street, Intramuros, Manila, represented herein by its Executive Director, RICO S. PABLEO JR. herein referred to as the" NCCA"

The LOCAL GOVERNMENT OF ORMOC CITY is a local government unit with principal address at Ormoc City Hall Building, Anubing Street, Government Center 6541 Leyte represented s represented in this act by its Mayor, RICHARD GOMEZ hereinafter referred to as the "GRANTEE".

WITNESSETH

WHEREAS, the Parties entered into Memorandum of Agreement dated April 19, 2018, copy of the said MOA is attached herein as Annex "A" for the project titled "EVAM Summit: 3 Day Basic Museology Workshop"

WHEREAS, the GRANTEE sent a letter to the NCCA requesting for the extension of the said Memorandum of Agreement. Copy of the said letter is attached herein as Annex 'B".

WHEREAS, the parties now desire to amend No. 6 of the MOA;

NOW THEREFORE, for and in consideration of the above premises, the parties have agreed to amend the MOA as herein provided.

- 1. No. 6 of the MOA shall be amended to be read as follows:
- "This AGREEMENT shall take effect on January 30, 2018 and shall continue to be in force until October 31, 2018, after such time the GRANT shall have been completed with all the terms and conditions herein satisfied."
- That the foregoing amendment to the Memorandum of Agreement shall take effect immediately.
- 3. That this amends the Memorandum of Agreement between the NCCA and the herein GRANTEE but all other provisions in the Memorandum of Agreement which is not affected by amendment shall remain the same and valid and shall also continue to bind the Parties accordingly.

- WITNESSETH -

WHEREAS, pursuant to R.A. 7356 the NCCA is mandated to encourage the continuing and balanced development of a pluralistic culture by the people, conserve and promote the nation's cultural heritage, ensure the widest dissemination of artistic and cultural products and preserve and integrate traditional culture and its various creative expressions as a dynamic part of the national cuitaral mainstream;

WHEREAS, the GRANTEE, a local government unit with a mission to be the agrocommercial and industrial gateway in Eastern Visayas and the Renewable Energy Capital of the Bhilippines, with a growth inclusive economy, in a disaster resilient environment, administered by an accountable local government:

WHEREAS THE PROJECT entitled "EVAM Summit: 3 Day Basic Museology Workshop" as particularly described in the Project Documents attached hereto as Annex "A" and the Line Item Budget attached hereto as Annex "A-2". The attached annexes are made integral parts of this agreement;

WHEREAS, the NCCA recognizes the true worth of the PROJECT as contributory to the development of Philippine culture and arts and has seen it fit, proper and convenient to adopt the same for its own purposes;

WHEREAS, the PROJECT, as proposed by GRANTEE, was approved by the Board of Commissioners under Resolution Number 2018-040 dated December 19, 2017 supported by way of financial assistance in the amount of One Hundred Twenty Thousand Pesos Only (PhP120,000.00) chargeable to the Program on Strengthening Culture-Sensitive Governance and Development a copy of which is attached hereto as Annex "B" and made an integral part of this agreement

NOW THEREFORE, the parties hereto mutually agree to undertake, execute and implement the PROJECT as enumerated herein in close collaboration and coordination with each other subject to the following terms and conditions:

1. The NCCA shall appropriate the sum of One Hundred Twenty Thousand Pesos Only (PhP120,000.00) as financial assistance to the Grantee to be released in the following manner subject to the issuance of Notice of Cash Allocation from the Department of Budget and Management:

- a) The first tranche of the GRANT amounting to **One Hundred Eight Thousand Pesos Only (PhP108,000.00)** or 90% of the Grant shall initially released to the GRANTEE upon compliance/submission of the following:
 - 1. Execution and notarization of Memorandum of Agreement between NCCA and Grantee:
 - 2. Issuance of Official Receipt by the Grantee for the first release;
 - 3. Certificate of Accreditation Issued by the NCCA;
 - 4. Proposed Schedule of Activities
- b) The amount of **Twelve Thousand Thousand Pesos Only** (*PhP12,000.00*) or 10% of the GRANT shall be released to the GRANTEE upon compliance of the following:
 - 1. Reports of Checks Issued [RCI] and /or Reports of Disbursement [RD] certified correct by the Accountant/Treasurer, approved by the Head of the Implementing Agency (IA) and duly certified by the Auditor of the IA (COA Circular 2012-001);
 - 2. Monitoring and Evaluation Report prepared by the NCCA-PMED;
 - 3. 1 Hardbound Terminal Report including photo documentation of the project (please refer to item 2.h for more details).
 - 4. Clear edited video documentation of the project in DVD format (please refer to 2.i) for more details;
 - 5. Acceptance of Output issued by the NCCA;
 - 6. Issuance of Official Receipt by the GRANTEE for the last release; and
 - 7. List of Accounts payable.
- 2. For its part, the GRANTEE shall:
 - a. Implement the Project according to the particularities stated in the Project Proposal, Line tem Budget Schedule of Activities/Gantt Chart and Board Resolution;
 - b. Keep an accounting of the Grant in accordance with generally accepted government accounting and auditing rules and regulations. The grantee shall maintain a separate Book of Accounts exclusively for the NCCA grant supported by receipts/documents and all records shall be made available for inspection by an NCCA staff or COA Auditor. It is understood that the Grantee shall be responsible for the sound and judicious administration/management of the project fund, otherwise the Grantee shall refund any disallowed disbursements as may be determined by the COA Auditor;
 - c. Act as lead implementer of the Project and shall be directly responsible for hiring, supervising and facilitating the release of the payment for services rendered by the project personnel hired on a contract basis which contract shall not exceed the duration of the Project. Applicable tax shall be deducted for payment of services rendered by project personnel. For this purpose, the Grantee shall be responsible for all applicable taxes and duties and its remittances to the local Bureau of Internal Revenue (BIR);
 - d. Coordinate regularly with the NCCA Officer for the implementation, monitoring and assessment of the Project through letter, phone or text messaging. The NCCA shall assign a counterpart officer who shall coordinate and monitor on a regular basis the progress of the project;

Executive Director RICO S. PABLEO, JR. e. Undertake the local and national promotion of the event and shall properly acknowledge the sponsorship of the NCCA in all media disseminations (e.g., press releases) and all other collateral materials to promote the event.

The minimum output shall be two (2) streamers exclusively acknowledging the NCCA as sponsor and placed at strategic locations. The Commission shall be correctly spelled out: "National Commission for Culture and the Arts (NCCA)." In the posters, flyers, invitations, press releases, and programs, the NCCA logo shall be of equal size or larger than the logo of other major sponsors. Acknowledgement shall be done before, during and after the program.

- Authorize the NCCA to include the project output, partially or entirely, in its website (www.ncca.gov.ph) and database and for use in the NCCA's promotional efforts, reports or other collateral materials as the NCCA deems necessary for the promotion of culture in the country. The NCCA agrees to acknowledge the source and authorship of the material used;
- g. Submit all liquidation reports as required by the NCCA within 2 months after the implementation of the PROJECT. The Report of Expenses shall be submitted to the NCCA NEFCA Division. Failure to submit the above reports within two (2) months after completion of the PROJECT shall mean cancellation of the remaining GRANT and disqualification of the GRANTEE from receiving financial assistance from the Commission in the future;
- h. Submit Final Report, including soft file copy, to the NCCA Plan/Policy Formulation and Programming Division. Terminal Reports shall be in accordance with the requirements of NCCA as provided for in the NCCA Guide on Terminal Report; and
- Terminal Report should be in the following format: (1) Hardbound Terminal Report in accordance with the NCCA Guide on terminal report (2) A DVD containing a non-editable PDF (Portable Document File) format of the Report readable in a standard computer. The DVD must be of high quality (ex. Imation, Sony) in transparent case and properly labeled. Photos must be saved in JPG files for possible use in NCCA publications.
- In case the Grantee fails to complete the project covered by this Memorandum of Agreement without justifiable reason, or there is a material violations of the provisions of the MOA, or of COA Circular, the NCCA shall institute legal action against the GRANTEE
- In case the amount granted for the project was not fully utilized by the GRANTEE, it must return to the NCCA any amount unutilized, including interest, if any
- For its part, The NCCA must officially acknowledge its acceptance of the completed PROJECT if the results indicated in the inspection reports so warrant.
- In case of the dissolution of the GRANTEE organization, voluntary or involuntary, the NCCA shall be given a lien by the GRANTEE on its assets, in accordance with existing laws, to the extent of the unexpended or unutilized portion of the fund.
- This AGREEMENT shall take effect on January 30, 2018 and shall continue to be in force until July 31, 2018, after such time the GRANT shall have been completed with all the terms and conditions therein satisfied.
- 7. Should there be an occurrence of any force majeure or similar condition which may delay or prevent the timely completion or fulfillment of this AGREEMENT and the attainment of its objective/s, the party with knowledge thereof shall notify the other in writing, specifying the cause and its implications and consequences upon the fulfillment of the GRANT, to enable the parties to adopt remedial measures.

In the event of unjustified failure of the GRANTEE to complete or fully implement the GRANT, in accordance with the terms and conditions stipulated in this AGREEMENT, or if the NCCA considered the PROJECT grossly unsatisfactory, or if there is any breach or violation thereof committed by the GRANTEE, the NCCA may forfeit the GRANT and terminate this AGREEMENT. Thereupon, the NCCA may take over the implementation/ execution of the GRANT without prejudice to holding the GRANTEE liable for the return/ reimbursement to the NCCA of the fund, or the balance thereof, received by the GRANTEE and for which it is accountable pursuant to this AGREEMENT. The GRANTEE shall also be liable under such civil action and/or criminal prosecution as may be warranted under existing
- 9. The parties shall mutually agree upon any amendment or modification of this AGREEMENT or its renewal. No modification or amendment of this AGREEMENT shall be valid unless the same is in writing and signed by both parties. No waiver of any provision of this AGREEMENT shall be valid unless it is in writing and signed by the party against whom it is sought to be enforced.
- 10. Failure of a party at any time to insist upon strict performance of any condition, promise, agreement or understanding set forth herein shall not be construed as a waiver or relinquishment of the same or other condition, promise, agreement or understanding at a future time.
