**A RESOLUTION APPROVING THE PURCHASE OF ONE (1) UNIT
BRAND NEW SERVICE VEHICLE FOR THE OFFICE OF THE
CITY ASSESSOR.**

WHEREAS, the Fourteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated February 28, 2018 from the Office of the City Mayor pertaining to the request of Mr. Arthur C. Arcuino, OIC- City Assessor, for authority to purchase One (1) unit brand new Service Vehicle to be used by the Office of the City Assessor in its day to day operations;

WHEREAS, the proposed purchase of brand new service vehicle is deemed vital towards the effective and efficient performance of the mandated functions of the Office of the City Assessor specifically in the continuous conduct of ocular inspections to appraise/assess real properties within the territorial jurisdiction of the city for taxation purposes;

WHEREAS, the necessary funds for the purchase of the brand new vehicle which is estimated to cost ONE MILLION TWO HUNDRED SEVENTY THOUSAND PESOS (P1,270,000.00) are available as certified by the City Budget Officer and the OIC- City Accountant through a Certificate of Availability of Funds dated March 5, 2018 which amount shall be taken from both the CY 2014 and CY 2017 Unexpended Continuing Appropriations: Capital Outlay- Motor Vehicle of the Office of the City Assessor;

WHEREAS, this Sanggunian finds the request as reasonable and most beneficial to public service, not contrary to law, public policy and morals, therefore is most deserving of prompt favorable support;
