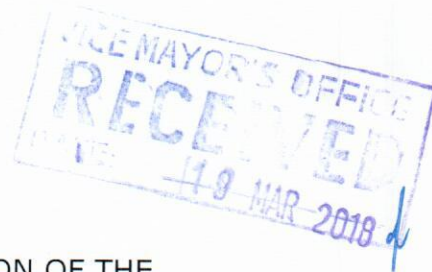

RESOLUTION NO. 2018-069

**A RESOLUTION APPROVING THE APPLICATIONS FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT
OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO.009 DATED OCTOBER 16, 2014 OF THE
FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:**

3. **JUATON UNITED FARMERS ASSOCIATION (JUFA)**

6. **FEDERATION OF EASTERN VISAYAS MOTORCYCLISTS ASSOCIATION (FEVMA), INC.**

WHEREAS, this august Body was in receipt of the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

1. Guintigui-an Farmers Association (GUIFA)
2. Dolores Farmers Association (DOLFA)
3. Juaton United Farmers Association (JUFA)
4. Mahayag United Small Farmers Association (MUSFA)
5. Lao Small Farmers Association (LASFA)
6. Federation of Eastern Visayas Motorcyclists Association (FEVMA), Inc.
7. Ormoc-Puertobello and Merida Multicab Operators and Drivers Association (OPMMODA)

WHEREAS, Guintigui-an Farmers Association (GUIFA) is a group of farmers residing in Brgy. Guintigui-an, Ormoc City registered under the Department of Labor and Employment (DOLE) and among its purposes of organization are to assist its members who are agrarian reform beneficiaries in acquiring the land awarded to them and claim support services through Agrarian Reform Programs of the government as well as to help its tenant farmer members in acquiring security of tenure of the land they till;

WHEREAS, Dolores Farmers Association (DOLFA) is a registered farmers association under the Department of Labor and Employment (DOLE) who are willing to participate in local governance in LGU-Ormoc to generate funds to sustain its programs, projects and activities for the mutual aid and protection of its members;

WHEREAS, Juaton United Farmers Association (JUFA) is composed of farmers from Brgy. Juaton, this City registered with the Department of Labor and Employment (DOLE). Among its purpose is to advance their rights as farmers as well as to develop the organization and the community into a sustainable and productive unit to improve the quality of life of its members;

WHEREAS, Mahayag United Small Farmers Association (MUSFA) is an association of farmers registered with the Department of Labor and Employment (DOLE) who are willing to get involved in the plans and programs of LGU-Ormoc in line with its goal to promote enterprise development activities that will improve the economic and social well-being of its members and its families;

WHEREAS, Lao Small Farmers Association (LASFA) is a non-stock, non-sectarian organization registered under the Department of Labor and Employment (DOLE) requesting for accreditation with LGU-Ormoc. Among its objectives is to serve as a channel for payment of land amortization as well as to act as catalyst for payment of loans or outright sale of farms to its members;

WHEREAS, Federation of Eastern Visayas Motorcyclists Association (FEVMA), Inc. is a Non-Government Organization (NGO) registered with the Securities and Exchange Commission (SEC). FEVMA is a group of motorcyclists of Eastern Visayas bound to support and participate in the government's plans, programs, and ideals as part of their vision and mission. Among its objectives is to develop and harness the character of its members in order to enrich and advance the cause of safe motorcycle riding, promote good relationship and cooperation among its members in the implementation of programs and projects;

WHEREAS, Ormoc-Puertobello and Merida Multicab Operators and Drivers Association (OPMMODA) is a legitimate association registered with the Department of Labor and Employment (DOLE). Among its primary objectives is to promote mutual aid and protection of its members and to work with non-government and government organizations or entities in the promotion and development of the association in carrying out government policies;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforementioned applications, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members as well as to address issues on livelihood capitalization through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by SP Members Tomas R. Serafica, Rolando M. Villasencio, Mario M. Rodriguez, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it
