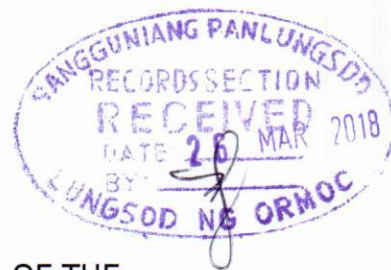

RESOLUTION NO. 2018-078

A RESOLUTION EXPRESSING UTMOST GRATITUDE AND APPRECIATION TO THE SANGGUNIANG PANLUNGSOD OF THE CITY OF DAVAO FOR EXTENDING FINANCIAL ASSISTANCE TO THE VICTIMS OF TYPHOON URDUJA THAT HIT THE CITY OF ORMOC IN THE AMOUNT OF ONE MILLION PHILIPPINE PESOS (PHP1,000,000.00).

WHEREAS, the City of Ormoc was placed under a State of Calamity when Tropical Depression Urduja pummelled the City of Ormoc with wind and rain which caused landslide in the mountainous areas and has flooded the lowland portions of the city.

WHEREAS, in line with desire to extend financial assistance to the City of Ormoc, the Sangguniang Panlungsod of the City of Davao passed an Ordinance numbered as Ordinance No. 0380-17 Series 2017, entitled: "AN ORDINANCE AUTHORIZING THE CITY MAYOR TO UTILIZE A PORTION OF THE THIRTY PERCENT (30%) QUICK RESPONSE FUND (QRF) OUT OF THE FIVE PERCENT (5%) DISASTER RISK REDUCTION AND MANAGEMENT FUND (CALAMITY FUND) OF THE CITY GOVERNMENT OF DAVAO FOR THE CALENDAR YEAR 2017, IN THE TOTAL AMOUNT EIGHT MILLION PESOS (Php8,000,000.00), TO EXTEND FINANCIAL ASSISTANCE TO THE VICTIMS OF TYPHOON URDUJA THAT HIT TACLOBAN CITY, ORMOC CITY, MUNICIPALITY OF CAN-AVID OF EASTERN SAMAR PROVINCE, MUNICIPALITY OF STA. FE OF THE PROVINCE OF LEYTE, MUNICIPALITY OF LLORENTE OF THE PROVINCE OF EASTERN SAMAR, MUNICIPALITY OF BARUGO OF THE PROVINCE OF LEYTE, PROVINCE OF NORTHERN SAMAR, PROVINCE OF SAMAR, MUNICIPALITY OF ZUMARRAGA, PROVINCE OF SAMAR, MUNICIPALITY OF BILIRAN, BILIRAN PROVINCE AND PROVINCE OF EASTERN SAMAR, SUBJECT TO THE EXISTING GOVERNMENT BUDGETING, ACCOUNTING AND AUDITING RULES AND REGULATIONS";

RESOLVED, AS IT HEREBY RESOLVED, to pass a RESOLUTION EXPRESSING UTMOST GRATITUDE AND APPRECIATION TO THE SANGGUNIANG PANLUNGSOD OF THE CITY OF DAVAO FOR EXTENDING FINANCIAL ASSISTANCE TO THE VICTIMS OF TYPHOON URDUJA THAT HIT THE CITY OF ORMOC IN THE AMOUNT OF ONE MILLION PHILIPPINE PESOS (PHP1,000,000.00);
