A RESOLUTION TRANSFERRING THE DATE OF THE REGULAR SESSION OF THE FOURTEENTH SANGGUNIANG PANLUNGSOD NG ORMOC TO MONDAY, MARCH 26, 2018 AT 9:00 O'CLOCK IN THE MORNING IN LIEU OF TUESDAY, MARCH 27, 2018, SAME TIME AT SAME WEEK.

WHEREAS, the Internal Rules of Procedure of the 14th Sangguniang Panlungsod ng Ormoc provides that its Regular Session shall be held on Thursday of every week at 9:00 o'clock in the morning;
