WHEREAS, this Sanggunian had adopted Resolution No. 2018 - 091 last April 12, 2018 approving the applications for Renewal of MTOP, Issuance of new MTOP, and granting franchise to a total of Nine (9) petitioners for Renewal of MTOP and Eighteen (18) petitioners for New MTOP respectively;
