RESOLUTION NO. 2018-100

A RESOLUTION APPROVING THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) OF THE CITY OF ORMOC FOR CY 2017-2023 AND THEREBY ADOPTING THE CITY DEVELOPMENT COUNCIL RESOLUTION NO. 09 SERIES OF 2017 ENTITLED: "A RESOLUTION APPROVING THE CY 2017-2023 COMPREHENSIVE DEVELOPMENT PLAN AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR APPROVAL OF THE SAME."

WHEREAS, an Indorsement was forwarded to this august Body from the Office of the City Mayor dated November 29, 2017 endorsing for its appropriate action the City Development Council (CDC) Resolution No. 9 Series of 2017 dated November 15, 2017 entitled: "A RESOLUTION APPROVING THE CY 2017-2023 COMPREHENSIVE DEVELOPMENT PLAN (CDP) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME" and further classifying the same as EXTREMELY URGENT;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that every local government unit should formulate a multi-sectoral development plan that shall embody its priority programs and projects and which shall serve as guide for the effective and efficient delivery of basic services and facilities to its constituents;

WHEREAS, the Comprehensive Development Plan (CDP) CY 2017-2023 serves as an adequate data base for multi-sectoral planning that will be used also as an implementation tool of the priority programs, projects and activities of the Local Government Unit of Ormoc (LGU-Ormoc);

WHEREAS, to recall, LGU-Ormoc had approved its last CDP that was otherwise known as the City Master Development Plan, thru Sangguniang Panlungsod Resolution No. 2000-021 dated February 10, 2000 entitled: "A RESOLUTION ADOPTING THE MASTER DEVELOPMENT PLAN/COMPREHENSIVE LAND USE PLAN, THE VISION OF WHICH IS TOWARDS SUSTAINABLE DEVELOPMENT WHICH IS SOCIALLY SOUND, ECONOMICALLY FEASIBLE & ENVIRONMENTALLY FRIENDLY AS RECOMMENDED BY OUR CONSULTANTS AND APPROVED BY THE CITY DEVELOPMENT COUNCIL (CDC) PER RESOLUTION NO. 2 S. 1998", with implementation period from 1999-2014, hence, the same having already expired and gone beyond its implementation period, there now arises an urgency and necessity, therefore, to approve a new CDP, which are the exact intents and purposes herein, a copy of which is attached herein and made an integral part hereof;

WHEREAS, this CDP is a multi-year plan for six years prepared by LGU-Ormoc thru the City Planning and Development Office (CPDO) utilizing diverse methods of exhaustive and in-depth data gathering and analysis, including but not limited to, researches, workshops, consultations and other objective, systematic and reliable means, in order to produce a plan that effectively promotes the general welfare of its inhabitants and serves as a useful guide for planners and implementers alike in the prompt and efficient delivery of services to the people;

WHEREAS, the formulation of the CDP had involved the participation of local officials and functionaries, sector representatives and other stakeholders in the prioritization of projects, programs and activities (PPAs) deemed essential for the attainment of LGU-Ormoc's vision;

WHEREAS, the CDP consolidates the PPAs designed to most effectively carry out the thrusts and objectives of the five (5) development sectors, namely: social, economic, physical land use, environmental management and institutional development and is deemed by its preparers as most responsive to the various sentiments and aspirations of Ormocanons;

WHEREAS, the CDP is reflective of the situation of the City of Ormoc and its aspirations for the people as the plan is a joint undertaking of multi-stakeholders that has evolved through participatory activities beginning at the barangay level up to city level consultations and workshops;

WHEREAS, to be able to fully implement the priority projects and programs of LGU-Ormoc that embody the directions, goals and objectives of the present administration, it is imperative and necessary, therefore, to approve and adopt the CDP CY 2017-2023 of the City of Ormoc;

WHEREAS, after a thorough study and evaluation of the CDP CY 2017-2023, this august Body finds that the articulation of the City's preferred development directions embodying the people's shared vision and development goals, objectives, strategies, priority programs and projects and legislative measures through the same is found to be indeed worthy and deserving of its prompt approval and affirmative action;
