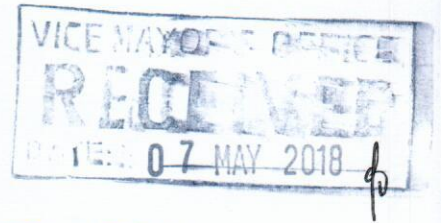

**RESOLUTION NO. 2018-104**

**A RESOLUTION INTERPOSING NO OBJECTION TO THE OPERATION OF ASTRAGALI GAMING CORPORATION OF PAGCOR E-GAMES LOCATED AT 2<sup>ND</sup> FLOOR, SUGARLAND SUITES, RIZAL STREET, ORMOC CITY AND BINGO BOUTIQUE UNIT 12, AL FRESCO, GAISANO RIVERSIDE MALL, BRGY. ALEGRIA, ORMOC CITY PROVIDED, IT CONFORMS TO PHILIPPINE AMUSEMENT AND GAMING CORPORATION AND GAMING SITE REGULATIONS.**

"WHEREAS, the Astragali Gaming Corporation represented by Jeffrey Billy Dagpin has submitted to the office of the City Mayor Richard I. Gomez a letter signifying their intention to secure a Letter of No Objection to operate E-games and Bingo Boutique in the City of Ormoc;

WHEREAS, the PAGCOR Charter PD1869 as amended by RA 9487 requires any site for PAGCOR operations to obtain the consent of the local government unit having territorial jurisdiction over the chosen site through a Letter of No Objection (LONO) as an initial requirement by PAGCOR Gaming Licensing and Development Department and subsequently a City Council Resolution;

"WHEREAS, the said applicant has properly secured the Certification Interposing No Objection to operate a "Traditional & Electronic Bingo" in the City, particularly in Bingo Boutique Unit 12, Al Fresco, Gaisano Riverside Mall, Ormoc City and 2<sup>nd</sup> Floor Sugarland Suites, Rizal Street, Barangay District 7 from the Mother of the Redeemer Parish, Cogon and Sts. Peter & Paul of Ormoc City;



"WHEREAS, the applicant has properly secured a Resolution Allowing Astragali Gaming Corporation To Operate At 2/F Sugarland Suites Located At J. Rizal St., District 7, Ormoc City from the Sangguniang Barangay District VII, Ormoc City, Resolution No. 002 – 18 S. 2017;

WHEREAS, the applicant has also properly secured a Resolution Allowing Astragali Gaming Corporation to Operate at Gaisano Riverside Mall located at Barangay Alegria from the Sangguniang Barangay of Alegria, Ormoc City, Resolution No.7 series of 2018;

WHEREAS, the Office of the City Mayor has issued a Letter of No Objection addressed to the Office of the Vice President of Gaming Licensing and Development Department, PAGCOR, to the operation by the Astragali Gaming Corporation of PAGCOR E-Games located at 2<sup>nd</sup> Floor, Sugarland Suites, Rizal St., and Bingo Boutique Unit 12, Al Fresco, Gaisano Riverside Mall, Brgy. Alegria, in the City of Ormoc;

"WHEREAS, after compliance with the requirements, the applicant was referred to the Office of the Chairman, Committee on Games and Amusement for an issuance of a resolution interposing no objection for the operation of said businesses in the City;

"WHEREAS, the Committee on Games and Amusement through its meeting has found no legal impediment thereby indorses for the approval of said letter request;

NOW THEREFORE, on motion of SP Member Vincent L. Rama, Chairman, Committee on Games and Amusement, severally seconded by SP Members Tomas R. Serafica, Eusebio Gerardo S. Penserga and Lea Doris C. Villar; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a A RESOLUTION INTERPOSING NO OBJECTION TO THE OPERATION OF ASTRAGALI GAMING CORPORATION OF PAGCOR E-GAMES LOCATED AT 2<sup>ND</sup> FLOOR, SUGARLAND SUITES, RIZAL STREET, ORMOC CITY AND BINGO BOUTIQUE UNIT 12, AL FRESCO, GAISANO RIVERSIDE MALL, BRGY. ALEGRIA, ORMOC CITY PROVIDED, IT CONFORMS TO PHILIPPINE AMUSEMENT AND GAMING CORPORATION AND GAMING SITE REGULATIONS;
