RESOLUTION NO 2018-105

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), EASTERN VISAYAS STATE UNIVERSITY- ORMOC CITY CAMPUS (EVSU-OCC) AND LIGA NG MGA BARANGAY, ORMOC CHAPTER FOR THE CONDUCT OF THE SANGGUNIANG KABATAAN (SK) MANDATORY TRAINING.

WHEREAS, an Indorsement was forwarded to this august Body from the Office of the City Mayor dated May 2, 2018, requesting for the issuance of a Resolution granting the City Mayor the authority to sign the Memorandum of Agreement (MOA) to be entered into by and among the Local Government Unit of Ormoc (LGU-Ormoc), the Department of Interior and Local Government (DILG), Eastern Visayas State University- Ormoc City Campus (EVSU-OCC) and Liga ng mga Barangay, Ormoc Chapter for the conduct of the Sangguniang Kabataan (SK) Mandatory Training and further classifying the same as EXTREMELY URGENT, a photocopy of the said MOA is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the approval of the SK Reform Act of 2015 or Republic Act No. 10742 on January 15, 2016, gave way to strengthen and empower the SK and transform it into a useful conduit for youth involvement in community development;

WHEREAS, the SK is given the responsibility to initiate and implement programs and projects designed to promote general welfare, development and empowerment of the youth;

WHEREAS, the passage of the said Act reflects the vote of the Filipino youth's ability to lead and participate in the country's development;

WHEREAS, Rule V, Section 30 of the Act's Implementing Rules and Regulations provides for capability building and orientation towards nation-building and empowerment, particularly in emphasizing the role of the youth in nation-building and molding them to become better citizens with the values of patriotism, nationalism and honor as a Filipino;

WHEREAS, the aforementioned section provides for mandatory and continuous training for any SK official, whether elected or appointed, or any member of the Local Youth Development Council (LYDC) before assuming their roles as prime movers in youth development;

WHEREAS, the law has mandated the National Youth Commission and the DILG with the assistance of the Development Academy of the Philippines (DAP), Local Government Academy (LGA), University of the Philippines— National College of Public Administration and Governance (UP-NCPAG) in consultation with youth stakeholders to jointly design and implement the mandatory and continuing training programs;

WHEREAS, the program shall include, among others, Philippine cultural history, political systems, ethics and ideologies, the Filipino as a nation builder, the Filipino youth and its role in nation building; and capability building on leadership, program and project development and sustainability, financial management, and accountability and transparency, and gender sensitivity;

WHEREAS, youth leaders will be taught the protocols, laws, responsibilities of their positions and how to effectively plan youth programs which will equip them with the necessary skills to perform their functions well;

WHEREAS, considering the magnitude of the task for the mandatory training, the DILG through the Local Government Academy, has spearheaded the development and conduct of Orientation and Workshop for Service Providers on the conduct of the SK Mandatory Training;

WHEREAS, the City Legal Officer issued a legal opinion dated April 30, 2018 stating that the MOA is in order, not detrimental to the interests of the City, not contrary to law, morals and public policy and recommends the approval of the aforementioned MOA following the specification of the support to be provided by the LGU to the SK Officials, a copy of the said letter is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that, along with strengthening the leadership skills of SK Officials and its aim to champion the cause of the youth, this matter is most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Lea Doris C. Villar; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), EASTERN VISAYAS STATE UNIVERSITY- ORMOC CITY CAMPUS (EVSU-OCC) AND LIGA NG MGA BARANGAY, ORMOC CHAPTER FOR THE CONDUCT OF THE SANGGUNIANG KABATAAN (SK) MANDATORY TRAINING.

MEMORANDUM OF AGREEMENT

Know All Men By This Presents:

This **Memorandum of Agreement (MOA)** is made and entered into by and among:

The **Department of the Interior and Local Government**, herein referred to as the "**DILG**", a government agency, created by virtue of Republic Act No. 6975 and operating under existing laws, with office address at Kanhuraw Hill, Tacloban City, and represented herein by its Regional Director, **MARIVEL C. SACENDONCILLO**, hereinafter referred to as "**First Party**";

The **City Government of Ormoc City**, herein referred to as "**LGU**", with office address at Aunubing St., Brgy. Cogon, Ormoc City, represented by its Local Chief Executive, **Hon. RICHARD I. GOMEZ**, hereinafter referred to as the "**Second Party**";

The **Eastern Visayas State University – Ormoc Campus, a Local Resource Institute (LRI)**, herein referred to as the "**Service Provider**", with office address at E. Conejos Street, Brgy. Don Felipe Larrazabal, Ormoc City, represented by its University President, **DR. DOMINADOR O. AGUIRRE, JR.**, hereinafter referred to as "**Third Party**";

The **Liga ng Mga Barangay, Ormoc Chapter**, herein referred to as the "**LIGA**", with office address at F. Ablen Street, Cogon, Ormoc City, represented by its President, **Atty. MARIANO Y. CORRO**, herein referred to as "**Fourth Party**";

WHEREAS, the approval of the Sangguniang Kabataan (SK) Reform Act of 2015 or R.A. 10742 on January 15, 2016, gave way to strengthen and empower the SK and transform it into a useful conduit for youth involvement in community development. Its passage reflects the vote of the Filipino youth's ability to lead and participate in the country's development;

WHEREAS, the implementing Rules and Regulations, Rule V, Section 30, of the Act states that "For the purpose of emphasizing the role of the youth in nation-building and modeling them to become better citizens with the values of patriotism, nationalism and honor as a Filipino, any SK official, whether elected or appointed, or any member of the LYDC must undergo the mandatory training program before she or he can assume office";

WHEREAS, the law mandated (Sec. 31 of R.A. 10742) the National Youth Commission and the DILG with the assistance of the Development Academy of the Philippines (DAP), Local Government Academy (LGA), University of the Philippines – National College of Public Administration and Governance (UP-NCPAG) and in consultation with youth stakeholders to jointly design and implement the mandatory and continuing training programs;

WHEREAS, these Institutions conducted series of consultation meetings and orientation to the service providers to develop the program framework to include among others the overall goal of the program, target, strategy of implementation, accreditation system and monitoring and evaluation system;

WHEREAS, considering the magnitude of the task for the mandatory training, the DILG through the Local Government Academy spearheaded the development and conduct of Orientation and Workshop for Service Providers on the conduct of SK Mandatory Training;

WHEREAS, the said activity is a complementary track to reinforce the conduct of the SK Mandatory Training Program by the Local Governance Regional Resource Center (LGRRCs). Local Academic Institutions as part of the Multi-Stakeholdership Advisory Council of the LGRRCs will be tapped to ensure a sustained effort in implementing the mandatory training. This intervention supports the NYC's strategy of providing the LYDOs training to lead and serve as raining managers in their respective LGU;

WHEREAS, the LGU having the jurisdiction over the barangays shall directly engaged with the SK through various mechanisms based on the provisions in the SK Reform Act;


WHEREAS, the Local Resource Institute a training institution is known for having expertise and is committed to providing high quality training and learning, are believed to be capable in managing and facilitating the conduct of the SK Mandatory Training in their regions.

NOW THEREFORE, for and in consideration of the above-premises, the parties agree, through their authorized officials, to enter into a Memorandum of Agreement under the following terms and conditions:

I. ROLES AND RESPONSIBILITIES OF THE PARTIES

DILG Regional Office

- a. Plan the regional implementation of the SK Mandatory Training;
- b. Issue the corresponding Regional Order/MC for the organization and institutionalization of the Regional, Provincial and City Management Team for the SK Mandatory Training;
- c. Provide directions and guidance to the Regional, Provincial and City Management Teams for the effective implementation of the training;
- c. Ensure that the training standards as defined by NYC, DILG and other Partners are adhered to in implementation of the said training;
- d. Ensure the participation of service providers to include among others, local resource institutions, academic institutions and local government units in the delivery of the training;
- e. Coordinate and discuss with the Local Government Unit the requirements of the SK Mandatory Training, including the role of the LRI as partner;
- f. Facilitate the issuance of the certificate of appearance and certificate of completion to the participants who complied with the requirements of the training;
- g. Submit to the DILG, LGA and NYC a consolidation report of accomplishments on the conduct of the SK Mandatory Training;
- h. Provide additional resource persons/speakers, if the necessity arises.



Local Government Unit, Ormoc City

- a. Ensure attendance of the duly elected SK Officials;
- b. Provide the needed support for the participation of the duly elected SK Officials;
- c. Allow the Supervising Admin Officer of the Public Affairs, Information and Assistance Division (PAIAD) and Local Youth Development Officer (LYDO), to be part of the City Management Team;
- d. Conduct Bidding for the lease of venue, food, supplies and materials to be used in the training if necessary, in accordance to RA 9184, upon recommendation of the City Management Team;
- e. Allow the use of needed facilities of the city government for free;
- f. Submit Observation Report with recommendations on how to further improve future training for the SK.


SERVICE PROVIDER, EVSU-Ormoc City Campus

- a. Manage and facilitate the conduct of the SK Mandatory Training;
- b. Provide documentation including secretariat services during the conduct of the training;
- c. Participate in the Regional and City planning and other coordination meetings for the conduct of the SK Mandatory Training;
- d. Select the Pool of Speakers in coordination with DILG and submit official list to the Training Director for accreditation;
- e. Submit a certified list to the DILG LGRRRC the list of Elected SK Officials who successfully completed the said training;
- e. Submit the terminal report that includes activity highlights, outputs, registration and attendance forms, and evaluation results; and
- f. Perform necessary undertaking, including regular coordinating with the DILG Regional Office, to ensure effective implementation of the activity.

LIGA NG MGA BARANGAY (LnB), ORMOC CITY CHAPTER

Duties and Functions of the Liga Treasurer

- a. Receive the registration fees for the SK Registration from the 110 component barangays of Ormoc City, 16 component barangays of Albueria, Leyte, and 23 component barangays of Kananga, Leyte.
- b. Issue Official Receipts for the registration fees received from the concerned barangays.
- c. Open a Trust Account in a government-owned/controlled bank for this purpose thru a Board Resolution of the Liga ng mga Barangay authorizing such act.
- d. Disburse for the payment with the corresponding receipts, vouchers and other pertinent supporting documents based on the proper written recommendation and approval of the SK Mandatory Training City Management Team for the following:



1. Honorarium of the resource speakers, facilitators and training staff;
 2. Food and Lease of Venue;
 3. Training Kits;
 4. Supplies and Materials; and
 5. Other Miscellaneous and related Expenses.
- e. Record all financial transactions in a separate book of accounts relative to the receipts and expenses incurred in the conduct of the said activity.
- f. Submit liquidation documents to DILG within six (6) days after the end of the SK Mandatory Training.
- g. Perform such other functions as may be deemed necessary for the successful conduct of the said activity.

II. EFFECTIVITY AND VALIDITY

This AGREEMENT shall take effect on the date of its signing without prejudice to revisions or modifications of any of the contracting parties, provided that such revisions or modifications are consistent to the original purpose of the Agreement and shall remain in full force until the completion of the implementation of the program.

Any revisions, amendment, or modification to this Agreement shall be conducted through a Supplemental Memorandum of Agreement for the purpose by the parties.

This Memorandum of Agreement (MOA) made and entered into and executed this 3 MAY 2017 day of ORMOC CITY 2017 at ORMOC CITY, Leyte, Philippines by and between;

The VISAYAS STATE UNIVERSITY, an institution of higher learning established under Pres. Decree No. 470 as amended by Pres. Decree No. 700, and converted into a state university by virtue of R.A. 9158 & 9437, with principal office at Visca, Baybay City, Leyte, duly represented by its University President, **DR. EDGARDO E. TULIN** hereinafter referred to as "VSU",

the

LOCAL GOVERNMENT UNIT OF ORMOC CITY, PROVINCE OF LEYTE, a political and corporate unit of government with the principal office in Ormoc City, Leyte, herein represented by its City Mayor **Honorable RICHARD I. GOMEZ** hereinafter referred to as "LOCAL GOVERNMENT UNIT OF ORMOC CITY, LEYTE"

and the

LIGA NG MGA BARANGAY ORMOC CITY CHAPTER, an Organization of all the Barangay Captains, herein represented by its Liga Chapter President **Honorable ATTY. MARIANO Y. CORRO**, hereinafter referred to as "LIGA"

WITNESSETH

WHEREAS, the Local Government Unit of Ormoc City, Leyte consisting of 110 more urbanized and developed barangays, serves as a general-purpose government for the coordination and delivery of basic, regular and different services and effective governance of the inhabitants within its territorial jurisdiction.

WHEREAS, the Visayas State University pursuit to provide excellent instruction, conduct relevant research and foster community engagement that produce highly competent graduates necessary for the development of the country/ is one of the seven original key regional member satellite SUCs of Barangay Integrated Development Approach for Nutrition Improvement (BIDANI) Network Program of the country; institutionalized BIDANI as a regular extension program at VSU formerly Visayas State College of Agriculture (ViSCA) in 1998; has a vital role in catalyzing, innovating and providing technical support in implementing BIDANI as SUCs Extension program/project/tool and as Local Government Units (LGUs) development strategy in local governance in program planning and management of PPAs; has the manpower capabilities and facilities to conduct applied research, and extension activities.

WHEREAS, the Barangay Integrated Development Approach for Nutrition Improvement (BIDANI) is a collaborative Extension and Action Research program of higher education and institutions-private and public; initiated by the State Universities and Colleges (SUCs), implemented in and for the barangays in partnership with the Local Government Units (LGUs), Government Organizations (GOs) and Non-Government Organizations (NGOs);

WHEREAS, BIDANI as SUCs extension program/project/ tool and as LGUs development strategy in local governance in program planning and management of Program/Projects/Activities (PPAs) supports/complements/supplements the implementation of the existing salient provision of the Government Local Autonomy & Decentralization program known as the Local Code of 1991; the Philippine Plan of Action for Nutrition (PPAN), Localization of the Millennium Development Goals (MDGs), and the Local Governance Performance Management System (LGPMS);

WHEREAS, the BIDANI program operationalize in three innovative project components that complements/supplements existing government laws and programs namely;

a) **Barangay Integrated Development Approach (BIDA)** - the process of implementing the BIDANI strategy through advocacy/linkaging or the process of generating and sustaining the active and coordinated participation of all sectors at various levels to facilitate adoption, implementation of BIDANI Strategy to accelerate development at the local levels and build capabilities of local government on *systematic, holistic, participatory, multi-sectoral, "bottom-up and integrated development planning, implementation and monitoring and evaluation* of projects embodied in a *Barangay Integrated Development Plan (BIDP/BDP)/Comprehensive Multi-sect oral Development Plans* (Sec. 106 RA7160);

b) **Barangay Management Information System (BMIS)** - a people based information system of gathering, organizing, storing & updating data about the barangay through training & technical backstopping, has a software developed in 2003 and registered the copyright to UPLB and deposited it in the National Library in March 01, 2008 under Registration No. N 2008-101; and

(c) **Participative Nutrition Enhancement Approach (PNEA)** a participatory, comprehensive and integrated nutrition enhancement package to ensure that nutrition services will be delivered by the LGU and other partners efficiently and effectively to achieve healthy community.

WHEREAS, BIDANI's envisage to improve nutrition and general well-being of the poor through more effective organizations of the barangay/municipal/city structure and improved capacities of local government in planning and management of program/projects/activities (PPAs) aimed at poverty alleviation and in meeting the basic needs of the populace; Its mission is to promote socio-economic development through a process of participative planning and appraisal of activities, facilitated by academic institutions of higher learning through their extension program, implemented by the barangay people in partnership with government and non-government agencies/organizations.

WHEREAS, adoption and operationalization of BIDANI as a development strategy in Local Governance entails a partnership development between SUC and LGU; VSU-BIDANI's role is to advocate and provide capacitating responsibility to partner stakeholders in operationalizing BIDANI as LGUs development strategy in program planning and management of PPAs; LGUs may provide resources for the implementation of development strategy during trainings and technical backstopping activities to 110 Barangay Development Council/Barangay Nutrition Committees/Sectoral functional committees.

WHEREAS, State Universities & Colleges (SUCs) are mandated to conduct and sustain an effective and efficient community extension services, the third element of the four-part core functions of SUCs -instruction, research, extension and production;

WHEREAS, the Local Code of 1991 (RA 7160) mandates Local Government Units (LGUs) to promote the general welfare and provide an effective and efficient basic social services and facilities enumerated in Sec. 16-17; LGUs represent the Provincial, City/Municipal/or Barangay.

WHEREAS, both BIDANI of VSU (ViSCA) and the Local Government of Ormoc City, Leyte Province recognize the need to empower/enhance capacities of Local Government Units (LGUs) for efficient and effective governance in partnership with government and non-government agencies for an integrated development efforts using the *BIDANI Strategy a delivery mechanism to accelerate rural and urban development of which nutrition is a key goal, an objective, a component, an outcome and indicator of development* to achieve self sufficiency and improved quality of life at the village level in a sustained and economical way consistent with the salient provision of the Government Local Code of 1991 (RA7160) and Philippine Plan for Action for Nutrition (PPAN), the Millennium/Sustainable Development Goals (S/MDGs) and the Local Governance Performance Management System (LGPMs);

WHEREAS, the parties hereto have mutual concerns and pledge their cooperation and support for the implementation of BIDANI Strategy in the City of Ormoc, Leyte;

WHEREFORE, in consideration of the above premises and their mutual covenants hereinafter set forth, the parties hereby set its responsibilities as follows;

The VSU-BIDANI

1. Establish and/or strengthen partnership with local governance stakeholders for the adoption of an integrated development initiatives using the BIDANI strategy in program planning and management - *resource generation and mobilization, implementation, monitoring and evaluation* of PPAs;
2. Utilizes and strengthen existing LGUs organizations to compose the Liga ng mga Barangay Sectoral Functional Committees (Section 112 of the Local Code RA7160) as the machinery in implementing the BIDANI strategy at the barangay;
3. Provide the knowledge and skills of existing LGUs functional committees of the Liga Ng Mga Barangay on the mechanics of implementing the BIDANI strategy at the barangay level;
4. Partnership with Sectoral Functional Committees of the Liga Ng Barangay in the conduct of *trainings and technical backstopping activities* to LGUs stakeholders/Local Nutrition Committees on BIDANI components: in program planning and management of PPAs- resource generation and mobilization, implementation, monitoring and evaluation using the BIDANI strategy (BIDA); establishment of Barangay Management Information System (BMIS) and implementation of a Participative Nutrition Enhancement Approach (PNEA).
5. Coordinate with technical experts of the university (SUCs) through their extension program of the Office of the Vice President for Research and Extension (OVPRE) for support services needed by the LGUs in the implementation of development program/projects/activities (PPAs) as stipulated in the local development plans using the BIDANI strategy;

The City of Ormoc:

1. Legitimizes the adoption of BIDANI strategy through Resolution/MOA and collaborate with existing Sectoral functional committees of the Liga ng mga Barangay who shall implement the strategy in partnership with SUCs extension staff, government and nongovernment agencies/organization to the 110 barangays of Ormoc City;

2. Adopts/integrates the basic concept of BIDANI Strategy in the agencies'/committee's role as enabler and catalyst in enhancing capacities of Local Government Units (LGUs)/Local Nutrition Committees for an efficient and effective delivery of social services to the constituents consistent with PPAN and the salient provision of the Local Autonomy and Decentralization Program of the government (RA 7160) and Local Governance Performance Management System (LGPMs);
3. Provides leadership through the City Development Council, City Nutrition Council and the Liga Ng Mga Barangay for the sustained implementation of the integrated nutrition-in-development initiatives at the local levels, using the BIDANI strategy thru an ordinance;
4. Mobilizes participation of Local Governance stakeholders in providing backstopping activities to Barangay LGUs in development planning, and management (*resource allocation and generation, implementation, monitoring and evaluating*) of development PPAs to achieve good governance, poverty alleviation and food security and ultimately redound to *health and nutrition improvement and general well being* of the populace; and
5. Provides supports to LGUs partner stakeholders and nutrition advocates in development undertakings using the BIDANI strategy.
6. Conducts regular consultative/feedbacking session/conference strategic planning/meeting among local governance stakeholders and nutrition advocates CNC and Liga Ng Barangay in the implementation of development programs/projects/activities stipulated in the local development plans of City and Barangay Integrated Development Plan (BIDP)/Comprehensive Multi-sectoral Development Plans (Sec. 106 RA 7160) and /or Local Nutrition Action Plan (LNAP).


The Barangay LGUs

1. The barangay as the basic political unit, serves as the primary planning and implementing unit of government policies, plans, programs, projects, and activities in the community (Sec. 384 RA 7160), adopts the BIDANI strategy thru a resolution for program planning and management (*resource allocation and generation, implementation, monitoring and evaluating*) of PPAs through a barangay resolution/ordinance;
2. Mobilizes and ensures participation of Barangay Development Council/Sectoral Functional Committees/nutrition committees in development planning and management of PPAs: in Sectoral planning-workshop and formulation of Barangay Integrated Development Plan (BIDP)/Comprehensive Multi-sectoral Development Plan (Sec. 106 & 109 RA 7160) and as basis in coming up with Annual Investment Program (AIP) and in filling-up the Barangay Nutrition Action Plan (BNAP) and other plans required; and
3. Allocate budget from development fund of the Internal Revenue Allotment Fund and conduct linkages from government agencies and NGOs and other stakeholders to source out funds to finance projects/activities that would provide the basic services and facilitates and for the general welfare of the constituents (Sec. 16 & 17 RA7160).
4. Come-up with a book bound Barangay Integrated Development Plan (BDP/BIDP) /Comprehensive Multi-Sectoral Development Plan (CMDP) as guide in implementing, monitoring and evaluating development PPAs.


