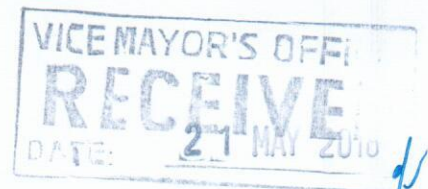
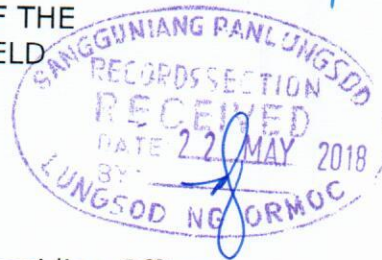

**RESOLUTION NO. 2018-112**

**A RESOLUTION EXPRESSING UTMOST GRATITUDE AND APPRECIATION TO THE LOCAL GOVERNMENT UNIT OF QUEZON CITY FOR EXTENDING FINANCIAL ASSISTANCE TO THE EARTHQUAKE VICTIMS OF ORMOC CITY IN THE AMOUNT OF TEN MILLION PHILIPPINE PESOS TO THE CITY OF ORMOC (Php10,000,000.00).**

WHEREAS, the City of Ormoc was struck by 6.5 earthquake last July 6, 2017 at 4:06 in the afternoon that has left 1,321 families from 13 various barangays displaced from their homes;

WHEREAS, in line with desire to extend financial assistance to the City of Ormoc, the Quezon City Council passed a resolution numbered as Resolution No. SP 7394, entitled: "A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO DONATE THE AMOUNT OF TEN MILLION PESOS (PHP 10,000,000.00) EACH TO THE CITY OF ORMOC AND KANANGGA, PROVINCE OF LEYTE WHICH WERE HARD HIT BY AN EARTHQUAKE OF 6.5 INTENSITY LAST JULY 6, 2017 WHICH HAS CAUSED HEAVY DAMAGE TO PROPERTIES AND HAD PLACED THEM IN A STATE OF CALAMITY";

WHEREAS, the invaluable support shown by the Local Government Unit of Quezon City is a manifestation of her kindred heart and partnership to the City of Ormoc in its incessant desire to rise from challenges;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it
