**A RESOLUTION APPROVING THE PURCHASE OF TWO (2)
UNITS BRAND NEW SERVICE VEHICLES FOR THE USE OF
THE SANGGUNIANG PANLUNGSOD.**

WHEREAS, the Office of Sangguniang Panlungsod Member Mario M. Rodriguez was in receipt of a letter from the Vice Mayor's Office, dated May 3, 2018, requesting the Committee on Finance and Appropriation for a Resolution approving the purchase of two (2) units Brand New service vehicles for the Sangguniang Panlungsod in view of the requirement set by the Department of Interior and Local Government (DILG) in all purchase of vehicles in government offices;

WHEREAS, the purchase of the two (2) units service vehicles will help in the effective and efficient performance of the mandate of the respective offices of the Sangguniang Panlungsod members;

WHEREAS, the necessary funds to cover the purchase of the proposed vehicle has already been appropriated per Appropriation Ordinance No. 2018-004 entitled "An Ordinance Reverting and Appropriating the Amount of One Million Seven Hundred Seventy Three Thousand One Hundred Fifty Philippine Pesos (Php1,773,150.00) to be Taken from Reversion of Year 2013-2016 Continuing Appropriation Under the Account of Furniture and Fixtures to Motor Vehicle of the Office of the Sangguniang Panlungsod." which was passed and approved by the 14th Sangguniang Panlungsod on April 12, 2018;

WHEREAS, the City Budget Officer, City Accountant and City Treasurer has issued a Certificate of Availability of Funds, dated March 6, 2018, as attached and made an integral part of Appropriation Ordinance No. 2018-004, stating therein that the required funds for the purpose is deemed available to be taken from reversion of years 2013-2016 Continuing Appropriation under the account of Furniture and Fixtures to Capital Outlay-Motor Vehicle Account of the Sangguniang Panlungsod;

WHEREAS, the Sanggunian finds that the request is reasonable and beneficial in terms of delivering fast and quality service to the public, geared towards good governance and administration, not contrary to law, public policy and morals and therefore, is most deserving of the august body's full support;

WHEREFORE, on motion presented by SP Member Benjamin S. Pongos, Jr., Vice-Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga and Mariano Y. Corro; be it
