**A RESOLUTION APPROVING THE APPLICATION FOR

WHEREAS, this Fourteenth Sangguniang Panlungsod ng Ormoc received the respective application for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit:

1. ORMOC UPHILL AGRI-PROCESSOR ASSOCIATION (OUAPA)
2. PLAN INTERNATIONAL INC
3. SAN PABLO HOLY CHILD HOMEOWNERS ASSOCIATION, INC.

WHEREAS, OUAPA is the first organization in Ormoc City to engage in the processing of locally produced fruit products specifically pineapples and jackfruits. The organization started its operation sometime in 2013 as a livelihood program geared towards the welfare of unemployed housewives in the locality. Further, OUAPA was duly registered with the Department of Labor and Employment (DOLE), has a license to operate as a food manufacturer issued by the Food and Drug Administration and a member of the Philippine Exporters Confederation, Inc.(PHILEXPORT);



WHEREAS, PLAN INTERNATIONAL INC. is a foreign company organized and existing under the laws of New York, United States which has a Philippine Representative Office duly licensed by the Securities and Exchange Commission (SEC) to transact Business in the Philippines in accordance with the Corporation Code of the Philippines and Foreign Investment Act of 1991. As a non profit organization, its primary purpose is to provide social and development services, and financial and material assistance to children and their needy families and communities;

WHEREAS, SAN PABLO HOLY CHILD HOMEOWNERS ASSOCIATION, INC. is a duly recognized association composed of homeowners, lot buyers, or long term lessees and occupants of lots or houses at Barangay San Pablo, Ormoc City and duly registered with the Housing and Land Use Regulatory Board (HLURB). Its primary concern is to facilitate the delivery of adequate social and economic services and advantages directed towards the improvement of the quality of life and well-being of its members;

WHEREAS, the aforementioned organizations desire to collaborate with the Local Government Unit of Ormoc in carrying out government issues, policies and programs that will benefit the Ormocanon community and promote development in the localities;

WHEREAS, the call for Accreditation of CSOs operating in Ormoc City is in accordance with Ordinance No. 009 dated October 16, 2014 entitled: " AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC";

WHEREAS, Section 2.1 of Ordinance No. 009 provide among others that an organization may still be accredited after the prescribed sixty (60) day period within which application for accreditation for membership in Local Special Bodies by any organization shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforementioned applications submitted by the aforementioned CSO applicants, finds that the same are in order and the objective of the sought accreditation is mainly to assist and work hand in hand with the LGU in various areas of concern and actively participate in the implementation of projects and programs that has positive impact to the respective association members;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;
