RESOLUTION NO. 2018-130

**A RESOLUTION INTERPOSING NO OBJECTION AND
APPROVING THE CONSTRUCTION OF CONCRETE ROAD
MILAGRO - CAMBANTOG - CABINGTAN - ALTO PEAK
ROAD LEADING TO LAKE JANAGDAN ALTO PEAK ORMOC
VEGETABLE FARM, BRGY. MILAGRO, ORMOC CITY, OF THE
DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS.**

WHEREAS, the Acting City Mayor Leo Carmelo L. Locsin, Jr. through an Endorsement Letter dated April 5, 2018 forwarded to this august Body for consideration the request of District Engineer Lino Francisco C. Gonzalez for the issuance of a Resolution Interposing No Objection for the project, entitled; "Construction of Concrete Road-Milagro-Cambantog-Cabingtang-Alto Peak Road Leading to Lake Janagdan Alto Peak Ormoc Vegetable Farm, Brgy. Milagro, Ormoc City", with a total cost of P159,280,000.00 funded under the General Appropriations Act (GAA) 2018 Infrastructure Program;

WHEREAS, the immediate subject matter of this Resolution is the construction of a concrete road named Milagro-Cambantog-Cabingtang-Alto Peak Road which includes the road widening of the existing Milagro to Cabingtang road, and the opening of a nine hundred twenty (920) meters road in Brgy. Cabingtang, as funded by the Department of Tourism; the end point of which shall serve as staging point for hikers and mountaineers intending to trek to Alto Peak;

WHEREAS, a Sangguniang Panlungsod Resolution Interposing No Objection for the aforementioned project and immediate subject matter is required by the Environment Management Bureau (EMB) for the processing and issuance of an Environmental Compliance Certificate (ECC), a requisite document before the Department of Works and Highways (DPWH) can proceed with the construction;

WHEREAS, the Department of Public Works and Highways (DPWH) conducted a consultation with the residents of Barangay Cabingtán in relation to the aforementioned project and was found out by the residents to be favourable and beneficial to the Barangay;

WHEREAS, the Sangguniang Pambarangay of Barangay Cabingtán issued Resolution No. 12 Series of 2018, expressing support and no objection of the aforementioned project, a copy of which is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, no objections were interposed at the Committee Meeting conducted by the Committee on Infrastructure Development of the Sangguniang Panlungsod of Ormoc City on April 23, 2018 duly attended by representatives from concerned offices, agencies, and baranggay officials;

WHEREAS, on June 5, 2018 a site visit was conducted by the members of the 14th Sangguniang Panlungsod together with the representative from the City Mayor's Office, Engineers of the Department of Public Works and Highways of the 4th District of Leyte, representatives from Environmentalist groups, and representative from the City Environment and Natural Resources Office - Ormoc where all concerns were clarified, and consequently all parties concerned assented to the project;

WHEREAS, the implementation of the aforementioned project would boost tourism by providing a platform for the Cabingtán Farmland to be visually appreciated, and by providing easier access to Alto Peak that could accommodate more mountaineers and hikers;

WHEREAS, the economic and tourism advantages that the implementation of said project bring to the Barangay and to the City of Ormoc outweighs the minimal environmental impact of the same;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the Office of the City Mayor, finds that the project is beneficial to the stakeholders and residents of Barangay Cabingtán and to the City of Ormoc and therefore, favourably endorses and interposes no objection to the implementation of the project, entitled; "Construction of a Concrete Road Milagro-Cambantog-Cabingtán Alto Peak Road Leading to Lake Janagdan Alto Peak Ormoc Vegetable Farm, Brgy. Milagro, Ormoc City";

WHEREFORE, on motion by SP Member Nolito M. Quilang, Member, Committee on Infrastructure Development, severally seconded by SP Members Tomas R. Serafica, Benjamin S. Pongos, Jr., Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION INTERPOSING NO OBJECTION AND APPROVING THE CONSTRUCTION OF CONCRETE ROAD MILAGRO - CAMBANTOG - CABINGTAN - ALTO PEAK ROAD LEADING TO LAKE JANAGDAN ALTO PEAK ORMOC VEGETABLE FARM, BRGY. MILAGRO, ORMOC CITY, OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS;




WHEREAS, there is an approved project for the Construction of a Concrete Road

stakeholders who will benefit of the said project;


WHEREAS, after due deliberation, the august body finds the project to be

FARM, BARANGAY MILAGRO, ORMOC CITY, LEYTE.


