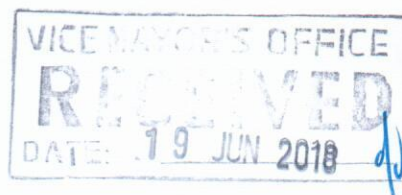


ADOPTED, June 14, 2018.


