## RESOLUTION NO. 2018-143

## A RESOLUTION CONFIRMING THE APPOINTMENT OF MARIA ELENA A. MENDOZA AS CITY GOVERNMENT DEPARTMENT HEAD I (CITY AGRICULTURIST).

WHEREAS, Section 454 (d) of RA 7160, otherwise known as the Local Government Code of 1391, provides that heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations and that the Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission;

WHEREAS, the appointment of Maria Elena A. Mendoza as City Government Department Head I (City Agriculturist) was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for confirmation on May 31, 2018 and was referred to the Committee on Good Government on June 7, 2018;

WHEREAS, after careful examination, scrutiny and review of the qualifications, records and experiences of the appointee pursuant to the requirements under Article 12, Section 482 of RA 7160, the Committee on Good Government finds the appointment meritorious considering that the appointee possesses all the minimum qualifications set by law for the position and that he has none of the disqualifications under the Local Government Code or other existing laws;

WHEREAS, the Committee on Good Government, upon motion of SP Member Benjamin S. Pongos, Jr. duly seconded by SP Member Mario M. Rodriguez and SP Member Gregorio G. Yrastorza III, interposes no objection to the said appointment and endorses the matter to the plenary;
