

RESOLUTION NO. 2018-144

A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU - ORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND - FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF - F4 TO LGUS) AND AFFIRMING THAT SUCH PROGRAMS/PROJECTS ARE PART OF THE DULY APPROVED CY 2018 ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY.

WHEREAS, an Endorsement dated June 11, 2018 from the OIC City Mayor, Rolando M. Villasencio, was submitted to this august Body requesting for the passage of a resolution endorsing the list of priority programs/projects of LGU – Ormoc to be funded under the Local Government Support Fund – Financial Assistance to Local Government Units (LGSF – FA to LGUs) and affirming that such programs/projects are part of the duly approved CY 2018 Annual Investment Program (AIP) of the City, a photocopy of the said list of programs/projects is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the requested resolution is pursuant to the requirements set under Item 3.0 of the Local Budget Circular (LBC) No. 117 dated February 5, 2018 with the subject, "Guidelines on the Release and Utilization of the Local Government Support Fund – Financial Assistance to Local Government Units (LGSF – FA TO LGUs) in the FY 2018 General Appropriations Act (GAA), Republic Act (RA) No. 10964";

WHEREAS, LGSF – FA to LGUs serves as the National Government's response to the various challenges faced by the LGUs in the exercise of their devolved service delivery functions, foremost of which is the raising of sufficient funds for local development. Hence, LGSF was included in the FY 2018 General Appropriations Act to cover, among others, financial assistance to LGUs as support for its priority programs and projects;

WHEREAS, LGU - Ormoc desires to avail of the said financial assistance to fund various priority programs/projects with a total amount of Twenty One Million Pesos (P21,000,000.00) all anchored on the present needs of the Ormocanons and deemed vital in moving forward the envisioned growth and development of the City;

WHEREAS, the listed programs/projects proposed for funding under the LGSF - FA to LGUs formed part of the approved CY 2018 AIP of LGU Ormoc after being identified and determined to be consistent with the City's development thrusts, thus, this Sanggunian fully supports the City Mayor's intention of favorably forwarding the subject list of projects/programs to be covered under the LGSF - FA program;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion by SP Member Rolando M. Villasencio, Chairman, Committee on Infrastructure Development, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Benjamin S. Pongos, Jr., Mario M. Rodriguez, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU - ORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND - FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF - FA TO LGUS) AND AFFIRMING THAT SUCH PROGRAMS PROJECTS ARE PART OF THE DULY APPROVED ANNUAL INVESTMENT PROGRAM (AIR) OF THE CITY;
