

**RESOLUTION NO. 2018-150**

**A RESOLUTION APPROVING THE AMENDMENT OF THE PROJECT TITLE UNDER CHAPTER 5, RANK NO. 58 OF THE LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) CY 2017-2020 TO INSTALLATION/REHABILITATION/RELOCATION/IMPROVEMENT OF STREET ILLUMINATION AND LIGHTING FIXTURE THEREBY ADOPTING THE CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 12, SERIES OF 2018.**

WHEREAS, an Indorsement was forwarded to this august Body from the Office of the City Mayor dated June 5, 2018 endorsing for its appropriate legislative action the City Development Council (CDC) Resolution No. 12, series of 2018 dated May 28, 2018 entitled: "A RESOLUTION APPROVING THE AMENDMENT OF THE PROJECT TITLE IN THE CY 2017 - 2020 LDIP THE REHABILITATION/RELOCATION/IMPROVEMENT OF STREET LIGHTING FIXTURE TO INSTALLATION/REHABILITATION/RELOCATION/IMPROVEMENT OF STREET ILLUMINATION AND LIGHTING FIXTURE AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME" ;

WHEREAS, this august Body approved the Comprehensive Development Plan (CDP) of the City of Ormoc for CY 2017 - 2023, as embodied in Resolution No. 2018 - 100 dated May 3, 2018 where which the Local Development Investment Plan CY 2017 - 2020 is part of;

WHEREAS, under the said approved CDP is the priority project under LDIP Chapter 5, page 16, rank 58 with project title: Rehabilitation/Relocation/Improvement of Street Illumination and Lighting Fixture with a project cost of Sixty Million Philippine Pesos (P 60,000,000.00);

WHEREAS, the City Development Council (CDC) adopted Resolution No. 12, series of 2018 amending the project title of the aforementioned project to Installation/Rehabilitation/Relocation/Improvement of Street Illumination and Lighting Fixture;

WHEREAS, as intended, there shall be included in the scope of subject project an installation of street illumination and lighting fixture, thereby making the activity not just the rehabilitation, relocation, and improvement of existing street illuminations and lighting fixture but includes the installation of new ones;

WHEREAS, the program of activities is the same, and the project cost is likewise the same;

WHEREAS, to be able to fully implement the project, it is necessary and imperative to amend the said project title;

WHEREAS, after thorough evaluation, this Sanggunian finds that the amendment of the project title is necessary, and is found to be consistent to the intended purpose and objective of the project, and of the City's developmental goals;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion by SP Member Rolando M. Villasencio, Chairman, Committee on Infrastructure Development, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Benjamin S. Pongos, Jr., Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
