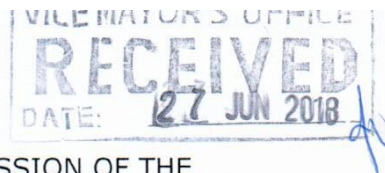

**RESOLUTION NO. 2018-154**

**A RESOLUTION EARNESTLY THANKING AND COMMENDING  
THE HONORABLE ATTY. MARIANO Y. CORRO FOR HIS  
EXEMPLARY AND DEDICATED SERVICE TO THE CITY OF  
ORMOC AS MEMBER OF THE SANGGUNIANG PANLUNGSOD  
NG ORMOC FOR NINETEEN (19) YEARS INCLUSIVE OF HIS  
SERVICES AS PRESIDENT OF THE LIGA NG MGA  
BARANGAY.**

WHEREAS, the Sangguniang Panlungsod ng Ormoc (SP) Member Mariano Y. Corro will be stepping down from government service thru expiration of term of office as ex-officio member of the 14<sup>th</sup> Sangguniang Panlungsod ng Ormoc and Liga ng mga Barangay ng Ormoc President on June 30, 2018;

WHEREAS, SP Member Corro's entry to the city government service started when he was first elected as a member of the Sixth Sangguniang Panlungsod on July 1, 1992 and served until June 30, 1995; then served again his second term as a re-elected Member of the Seventh Sangguniang Panlungsod from July 1, 1995 to June 30, 1998; and then served again his third term as a re-elected Member of the Eight Sangguniang Panlungsod from July 1, 1998 to June 30, 2001, after which during the interim term, he had to rest due to the three-term limit set on elected city officials;

WHEREAS, he was elected and served again as Member of the Tenth Sanggunian from July 1, 2004 to June 30, 2007; and then served again as a re-elected Member of the Eleventh Sanggunian from July 1, 2007 to June 30, 2010;

WHEREAS, after the 2010 elections, his services was again engaged by the City Government, this time as Legal Consultant wherein he served such position from August 1, 2010 to June 30, 2013, which service saw him contributing significantly in addressing and resolving various legal issues then plaguing the City;



WHEREAS, he was also elected as Punong Barangay of Barangay District 13 during the May 2013 Barangay Elections, and subsequently elected as President of the Liga ng mga Barangay, thus paving the way for his return as ex-officio Member of the Thirteenth and Fourteenth Sanggunian from December 23, 2013 until June 30, 2018;


