RESOLUTION NO. 2018-157

**A RESOLUTION ENDORSING THE MEMBERSHIP OF THE CITY
MAYOR RICHARD I. GOMEZ TO THE PROTECTED AREA
MANAGEMENT BOARD (PAMB), AND GRANTING HIM THE
AUTHORITY TO REPRESENT FOR AND ON BEHALF OF THE
LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) IN
SAID BOARD.**

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated May 29, 2018, requesting therein for the passage of a resolution endorsing the membership of the City Mayor Richard I. Gomez to the Protected Area Management Board (PAMB), and granting him the authority to represent for and on behalf of the Local Government Unit of Ormoc in said Board;

WHEREAS, Section 11 of Republic Act No. 7586, also known as the National Integrated Protected Areas System (NIPAS) Act of 1992 provides for the creation and composition of the Protected Area Management Board (PAMB), as well as the manner of appointment of the members for each of the establishment protected area;

WHEREAS, Republic Act No. 7586 provides that one (1) representative from the city/municipal government shall be included as one of the Protected Area Management Board (PAMB) member;

WHEREAS, Section 444 of RA 7160 or the Local Government Code of 1991 provides that the City Mayor as the highest ranking official and the chief executive of the Local Government Unit (LGU) shall exercise general supervision and control over all programs, projects, services, and activities of the city government;

WHEREAS, the City Mayor, considering his position and official functions, is the ideal person to represent LGU Ormoc in said Board;

WHEREAS, the Committee on Environment and Natural Resources, after thorough deliberation, approved to endorse the membership of the City Mayor Richard I. Gomez to the Protected Area Management Board (PAMB), and grant him the authority to represent for and on behalf of the Local Government Unit of Ormoc in said Board at the Committee Level on a Committee Meeting held last June 19, 2018 at the Sangguniang Panlungsod Conference Room;

WHEREAS, upon close and thorough review, this Sanggunian finds that said endorsement and grant of authority is not contrary to law, public policy, public morals and good customs, and that the aim of this undertaking is highly noble that will greatly benefit the City of Ormoc and its environment, so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Gregorio G. Yrastorza III, Chairman, Committee on Environment and Natural Resources, severally seconded by SP Members Tomas R. Serafica, John Eulalio Nepomuceno O. Aparis II and Jasper C. Yerro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION ENDORSING THE MEMBERSHIP OF THE CITY MAYOR RICHARD I. GOMEZ TO THE PROTECTED AREA MANAGEMENT BOARD (PAMB), AND GRANTING HIM THE AUTHORITY TO REPRESENT FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) IN SAID BOARD;
