**A RESOLUTION APPROVING AND GRANTING AUTHORITY TO
PURCHASE ONE (1) UNIT BRAND NEW SERVICE VEHICLE
FOR THE USE OF THE OFFICE OF THE BUILDING OFFICIAL
(OBO) SUPERCEDING SP RESOLUTION NO. 247 SERIES OF
2017.**

WHEREAS, forwarded to this august Body for consideration is a 2nd Endorsement Letter, dated June 18, 2018, from the City Mayor's Office (CMO), pertaining to the request of Engr. Sonia B. Antonio, OIC-Building Official, for a Resolution granting authority to purchase one (1) unit Service Vehicle with an estimated cost of ONE MILLION EIGHT HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,800,000.00);

WHEREAS, the Office of the Building Official (OBO) functions as the primary administering office to implement regulations, examine permits and requirements for construction, repair, use, occupancy and conversion as well as demolition of buildings in conformity with the National Building Code of the Philippines;

WHEREAS, the OBO is mandated to perform complex functions geared towards ensuring a timely evaluation and processing of building-related documents as well as strict enforcement of building policies. Relative thereto, the Office diligently conducts regular inspections within the city thus, the need to procure a service vehicle for easy mobilization and to effectively carry out its mandate;

WHEREAS, on November 2, 2017, Resolution No. 2017-247 was passed by this Body entitled, "A RESOLUTION APPROVING THE PURCHASE OF ONE (1) UNIT BRAND NEW SERVICE VEHICLE FOR THE OFFICE OF THE BUILDING OFFICIAL (OBO) USE," which service vehicle was estimated to cost ONE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,500,000.00);

WHEREAS, after a more thorough perusal and consideration of the tasks and functions of their office, OBO is reconsidering the purchase of said service vehicle with specifications as provided in an attachment of Resolution No. 2017-247, and herein requesting for the purchase of a brand new service vehicle with specifications that is more suitable to the demanding tasks involved – including, but not limited to, inspection of high terrain areas and in areas with unpaved roads, or both;

WHEREAS, the OIC-City Accountant issued a Certificate of Availability of Funds, dated May 29, 2018, stating therein that the amount of ONE MILLION EIGHT HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,800,000.00) is available to be taken from CY 2018 Trust Liabilities -15% OBO Fund of the OBO, a copy of said certification is attached as Annex "A" and made an integral part hereof;

WHEREAS, the Sanggunian finds that the request is meritorious, reasonable, and necessary for the improvement and betterment in the delivery of quality services to the public by OBO, and not contrary to law, public policy and morals and therefore, is most deserving of the august Body's full support;

WHEREFORE, on motion presented by SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Gregorio G. Yrastorza III, Tomas R. Serafica and Jasper C. Yerro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION APPROVING AND GRANTING AUTHORITY TO PURCHASE ONE (1) UNIT BRAND NEW SERVICE VEHICLE FOR THE USE OF THE OFFICE OF THE BUILDING OFFICIAL (OBO) SUPERCEDING SP RESOLUTION NO. 247 SERIES OF 2017;
