RESOLUTION NO. 2018-160

A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE PROGRAM, ENTITLED: "HOSPITALIZATION ASSISTANCE TO INDIGENT PATIENTS", IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,500,000.00) TO BE FUNDED FROM THE AN WARAY PARTY LIST ALLOCATION UNDER THE CY 2018 LOCAL GOVERNMENT SUPPORT FUND FINANCIAL ASSISTANCE TO LGUS (LGSF-FA TO LGUS), AND AFFIRMING THAT THE PROPOSED PROGRAM FOR FUNDING IS PART OF THE DULY APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM CY 2017-2023 AND THE ANNUAL INVESTMENT PROGRAM (AIP) OF CY 2018 OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY.

WHEREAS, the Sangguniang Panlungsod received an Indorsement Letter, dated June 26, 2018, from the Office of the City Mayor (CMO), requesting for the issuance of a Resolution endorsing the program, entitled: "Hospitalization Assistance to Indigent Patients", in the amount of ONE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS ONLY (PHP1,500,000.00) to the An Waray Party List under their allocation for CY 2018 Local Government Support Fund Financial Assistance to LGUs (LGSF-FA to LGUs), affirming that such programs/projects are part of the duly approved Local Development Investment Program (LDIP) CY 2017-2023 and CY 2018 Annual Investment Program (AIP) of the City, and requesting that this matter be treated as extremely urgent;

WHEREAS, Sec. 2, Art. XIII of the Philippine Constitution provides that "The state shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all people at affordable cost.";

WHEREAS, the requested resolution is pursuant to the requirements under Item 3.0 of the Local Budget Circular (LBC) No. 117, dated February 5, 2018, with the subject, "Guidelines on the Release and Utilization of the Local Government Support Fund – Financial Assistance to Local Government Units (LGSF – FA to LGUs) in FY 2018 General Appropriations Act (GAA), Republic Act (RA) No. 10964";

WHEREAS, LGSF – FA to LGUs serves as the National Government's response to the various challenges faced by the LGUs in the exercise of their devolved service delivery functions, foremost of which is the raising of sufficient funds for local development. Hence, LGSF was included in the FY 2018 General Appropriations Act to cover, among others, financial assistance to LGUs as support for its priority programs and projects;

WHEREAS, LGU-Ormoc desires to avail of the said financial assistance in the total amount of ONE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP 1,500,000.00) to fund its proposed program, entitled: "Hospitalization Assistance Program to Indigent Patients," with the objective of ensuring that Ormocanons who are poor/indigents and in dire need of quality health care, who are not enrolled in any Philhealth Assistance Program, can avail of quality health services from government hospitals, a copy of project proposal for herein subject program is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the subject proposed program for funding under CY 2018 LGSF – FA to LGUs forms part of the duly approved LDIP CY 2017-2023 and CY 2018 AIP of LGU Ormoc after being identified and determined to be consistent with the City's development thrusts, thus, this Sanggunian fully supports the City Mayor's intention of favorably forwarding the said program to be funded under the An Waray Party List allocation;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion by SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III, Jasper C. Yerro and John Eulalio Nepomuceno O. Aparis II; be it



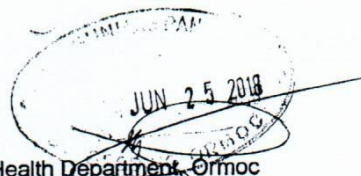

PROJECT BRIEF TEMPLATE FOR THE PROPOSED PROJECT.

I. BASIC INFORMATION :

Name of Project: Hospitalization Assistance Program to Indigent Patients.

Implementing Agency: City Health Department, Administrative Division and the City Social Welfare and Development Office.

Objective: To ensure that Ormocanons that are Poor/ Indigent and in dire need of Quality Health Care who are not enrolled in any PhilHealth Program, shall have the priority of availing of the Hospitalization Assistance Program.

Target Beneficiaries: Infants, Women, Children, Adolescent, Adult, Elderly and Persons With Disability (PWD) coming from the Different Barangays of our City who are poor/ Indigent who are confined to a Government Hospital.

Recipient Gov't. Hospital: ORMOC DISTRICT HOSPITAL

Budget: ₱1,500,000.00

II. PROJECT RATIONALE:

Article II, Section, I of the Philippines Constitution, states that the State shall protect and promote the right to Health of the people and to instill health consciousness among them', and Article XIII, section II further states that. "The state shall adopt an integrated and comprehensive approach to Health development which shall endeavour to make essential Goods, Health and other Social Services available to all people at affordable cost."

It is this mandate that sets as the bases for the implementation of this Hospitalization Assistance for Indigent Patients.

III. GENERAL POLICIES :

1. **Identification of Qualified – Sponsored Patients** - Shall be done thru an interview by the CSWDO Social Worker in- charge of the Program.
2. **Assistance Cost and Coverage**
 - a.) **Rate** - The amount of assistance shall be ₱1,000.00 per patient to cover at least 1500 beneficiaries for the entire duration of this particular program.

b.) **Validity** – The coverage of the HAP shall be from the first day of the approval of this Program and shall end on the last working day of the Calendar year.

3. Benefits:

Health Assistance Program (HAP) shall be paid immediately to the Government Hospital e.i. Ormoc District Hospital where the Patients are confined, upon submission of a Billing Statement to the City Government indicating the Names and Address of the patient with the attached required documents as follows:

- a.) Medical certificate/Clinical abstract with signature and License no. of the attending physician.
- b.) Certificate of Indigency from the Baranggay of Residence.
- c.) Valid I.D. of the Client
- d.) Report from Medical Social Worker or from the CSWDO indicating that the patient or client is Indigent.
- e.) Sickness Validation Certificate from the City Health Department – for purposes of monitoring and evaluation of the program and in consideration to utilization of benefits and other pertinent health statistical reports.

IV. Computation of Needs: 1600 In-Patients

1500 Patients at ₱1,000.00 Hospital Assistance per Patients =
₱1,500,000.00.

V. Monitoring and Evaluation:

The City Government of Ormoc Thru the implementing Departments shall device a mechanism for monitoring and ensure that the program is properly and effectively implemented.

VI. Effectivity :

This Hospitalization Assistance Program (HAP) for Indigent Patients shall take effect immediately upon approval by the LGSF-FA.


