**RESOLUTION NO. 2018-164**

**A RESOLUTION ACCEPTING WITH REGRETS THE  
RESIGNATION OF HONORABLE SP MEMBER ROLANDO M.  
VILLASENCIO AS MEMBER OF THE FOURTEENTH  
SANGGUNIANG PANLUNGSOD OF ORMOC CITY.**

WHEREAS, in a letter dated July 2, 2018 addressed to the Honorable Vice Mayor Leo Carmelo L. Locsin, Jr., incumbent Sangguniang Panlungsod Member Rolando M. Villasencio tendered his irrevocable resignation as Member of the Fourteenth (14<sup>th</sup>) Sangguniang Panlungsod of Ormoc City;

WHEREAS, this august Body treats such a decision with utmost respect, even though it would mean missing SP Member Villasencio's remarkable presence in the chamber along with his zeal, dedication and sincerity in serving the people of Ormoc;

WHEREAS, Section 82 Par. (a) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, has thus stated:

"(a) Resignation by elective local officials shall be deemed effective only upon acceptance by the following authorities:

(1) X X X X

(2) X X X X

- (3) The sanggunian concerned, in the case of Sangguniang members, X X X X"

Further, sub-par. (4)(d) of said Article also states that:

"(d) Irrevocable resignations by the sanggunian members shall be deemed accepted upon presentation before an open session of the sanggunian concerned and duly entered in its records." X X X X

WHEREFORE, in view of the aforesaid provisions of the Local Government Code, this august Body deems it necessary to manifest its acceptance and to accede to the said resignation, of SP Member Villasencio as Member of the 14<sup>th</sup> Sangguniang Panlungsod ng Ormoc, for purposes of good governance;

NOW, THEREFORE, motion of SP Member Mario M. Rodriguez, Member, Committee on Laws and Ordinances and Committee on Internal Rules of Procedures, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III and John Eulalio Nepomuceno O. Aparis II; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION ACCEPTING WITH REGRETS THE RESIGNATION OF HONORABLE SP MEMBER ROLANDO M. VILLASENCIO AS MEMBER OF THE FOURTEENTH SANGGUNIANG PANLUNGSOD OF ORMOC CITY;


ADOPTED, July 05, 2018.

Dear Vice Mayor Locsin,


It has been a long and difficult decision, but all things considered, I hereby resign as Member of the 14<sup>th</sup> Sangguniang Panlungsod.
