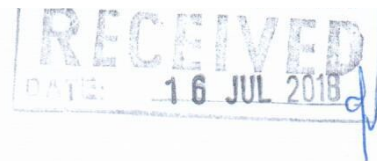

RESOLUTION NO. 2018-165

A RESOLUTION RECOGNIZING MELBUR N. MELGAZO AS THE ACTING LIGA NG MGA BARANGAY ORMOC CITY CHAPTER PRESIDENT AND FURTHER, ACCEPTING AND RECOGNIZING HIS ASSUMPTION AS EX-OFFICIO MEMBER OF THE FOURTEENTH SANGGUNIANG PANLUNGSOD NG ORMOC EFFECTIVE JUNE 30, 2018.

WHEREAS, the Fourteenth Sangguniang Panlungsod ng Ormoc received a communication dated July 1, 2018 from Melbur N. Melgazo, incumbent Vice President of the Liga ng mga Barangay Ormoc City Chapter and duly reelected Punong Barangay of Barangay Linao, Ormoc City, informing the august Body of his assumption as the Acting Liga ng mga Barangay (LnB) Chapter President effective June 30, 2018 and of his representation to the Sanggunian as Ex-Officio Member;

WHEREAS, the assumption of Mr. Melgazo as LnB Acting President and as Ex-Officio Member of the Fourteenth Sanggunian is in succession of the vacancy in the Office of the LnB President due to the expiration of the term of office of Punong Barangay Mariano Y. Corro last June 30, 2018, who was then the LnB Local Chapter President and an Ex-Officio Member of this Sanggunian;

WHEREAS, Section 2, Article XII of the 2016 LnB Constitution and By Laws provides that:

Section 2. Vacancies and Succession. In case of a permanent vacancy in the Office of the President due to refusal to assume office, death or removal from office on the grounds provided in Section 4 of this Article, voluntary resignation, permanent incapacity to discharge the duties and functions of president, or fails to comply with his undertaking executed in accordance with Article VI, Section 1.5 of the Liga Election Code , the Executive Vice President in the case of the National Liga or the Vice President, in the case of local chapters, shall assume the office of the unexpired term of the President. Succession shall take effect only after confirmation by the National Executive Board in accordance with Article IX, Section 2 of the Liga Election Code. The Vice President who assumes the position of President by succession shall represent the Liga Chapter in the Sanggunian concerned upon presentation therein of his Certificate of Confirmation.

WHEREAS, Mr. Melgazo submitted a Certificate of Confirmation from the Liga ng mga Barangay sa Pilipinas dated June 28, 2018 confirming his assumption as the Acting Liga Chapter President of the Liga ng mga Barangay of Ormoc City, a copy of which is hereto attached as integral part hereof;

WHEREAS, this Sanggunian, finds the subject assumption of Mr. Melgazo to be in order and not contrary to existing laws, rules and regulations hence, most deserving of prompt favorable action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Member, Committee on Good Government, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Jasper C. Yerro, be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION RECOGNIZING MELBUR N. MELGAZO AS THE ACTING LIGA NG MGA BARANGAY ORMOC CITY CHAPTER PRESIDENT AND FURTHER, ACCEPTING AND RECOGNIZING HIS ASSUMPTION AS EX-OFFICIO MEMBER OF THE FOURTEENTH SANGGUNIANG PANLUNGSOD NG ORMOC EFFECTIVE JUNE 30, 2018;
