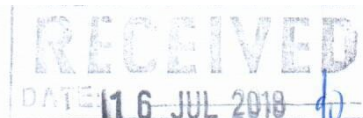

RESOLUTION NO. 2018-166

**A RESOLUTION CONFIRMING THE APPOINTMENT OF
ROSARIO G. SERAFICA, AS CITY GOVERNMENT
DEPARTMENT HEAD I (CITY ACCOUNTANT).**

WHEREAS, Section 454 (d) of RA 7160, otherwise known as the Local Government Code of 1991, provides that heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations and that the Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission;

WHEREAS, the appointment of Mrs. Rosario G. Serafica as City Government Department Head I (City Accountant) was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for confirmation on June 25, 2018 and was referred to the Committee on Good Government on July 5, 2018;

WHEREAS, after careful examination, scrutiny and review of the qualifications, records and experiences of the appointee pursuant to the requirements under Article 4, Section 474 of RA 7160, the Committee on Good Government finds the appointment meritorious considering that the appointee possesses all the minimum qualifications set by law for the position and that she has none of the disqualifications under the Local Government Code or other existing laws;

WHEREAS, the Committee on Good Government, upon motion of SP Member Vincent Rama duly seconded by SP Member Benjamin S. Pongos Jr. and SP Member John Eulalio Nepomoceno O. Aparis II, interposes no objection to the said appointment and endorses the matter to the plenary;

WHEREFORE, on motion of SP Member Vincent L. Rama, Member, Committee on Good Government, severally seconded by SP Members Mario M. Rodriguez, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II and Lea Doris C. Villar; be it

RESOLVED, by the Sangguniang Panlungsod in session assembled to confirm, as it is hereby confirmed, the appointment of Rosario G. Serafica as City Government Department Head I (City Accountant);




