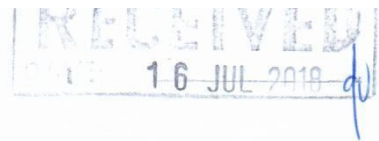

RESOLUTION NO. 2018-167

A RESOLUTION AUTHORIZING AND DESIGNATING MR. VINCENT L. EMNAS, CITY ADMINISTRATOR, AS A DULY AUTHORIZED SIGNATORY TO SIGN ALL TRANSACTIONS RELATIVE TO THE TRUST FUND ACCOUNT OPENED BY THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE LANDBANK OF THE PHILIPPINES FOR PHILHEALTH CAPITATION FUND THROUGH RESOLUTION NO. 2017-248.

WHEREAS, the Sangguniang Panlungsod was in receipt of an Endorsement Letter from the City Mayor's Office (CMO), dated July 3, 2018, endorsing to this august Body, for consideration, the request of Dr. Nelita D. Navales, City Health Officer I, to grant Mr. Vincent L. Emnas, City Administrator, the authority to sign all transactions re the Trust Fund Account opened with Land Bank of the Philippines for PhilHealth Capitation Fund;

WHEREAS, on October 30, 2017, Resolution No. 2017-248 was passed by the Sangguniang Panlungsod, entitled: "A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ AND THE CITY TREASURER, MS. DELIA C. VILBAR TO OPEN AN EXCLUSIVE TRUST FUND ACCOUNT WITH LANDBANK OF THE PHILIPPINES – ORMOC BRANCH FOR THE PHILHEALTH PHILIPPINE CAPITATION FUND (PCF) TO SERVE AS THE DEPOSITORY ACCOUNT FOR ALL PHILHEALTH REIMBURSEMENTS FOR THE CITY HEALTH OFFICE (CHO)";

WHEREAS, the opening of the account was in pursuance of PhilHealth Circular No. 2017-0020 for the Implementation of Auto-Credit Payment Scheme (ACPS) to all Health Care Institutions to improve claim process efficiency through the automation of PhilHealth's payment mechanism with the Health Care Institution's banking service providers;

WHEREAS, at present, no transaction has been made to the abovementioned account due to the absence of an authorized signatory to the newly opened account as Resolution No. 2017-248 only authorizes the City Mayor, Richard I. Gomez and the City Treasurer, Ms. Delia C. Vilbar to open said account;

WHEREAS, upon close and thorough review of the endorsement and request therein, this august Body finds that authorizing City Administrator, Mr. Vincent L. Emnas as signatory of abovementioned account is geared towards the effective implementation of PhilHealth Circular No. 2017-0020 that would redound to the greater benefit of the city and its constituents, and the same was found to be in order, not detrimental to the interests of the city, not contrary to law, morals and public policy, and so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, jointly seconded by SP Members Tomas R. Serafica and John Eulalio Nepomuceno O. Aparis II; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING AND DESIGNATING MR. VINCENT L. EMNAS, CITY ADMINISTRATOR, AS A DULY AUTHORIZED SIGNATORY TO SIGN ALL TRANSACTIONS RELATIVE TO THE TRUST FUND ACCOUNT OPENED BY THE LOCAL GOVERNMENT UNIT OF ORMOC WITH THE LANDBANK OF THE PHILIPPINES FOR PHILHEALTH CAPITATION FUND THROUGH RESOLUTION NO. 2017-248;

ADOPTED, July 12, 2018.
