RESOLUTION NO. 2018-174

**A RESOLUTION APPROVING THE SITE REPLACEMENT FOR
THE YOLANDA COMPREHENSIVE REHABILITATION AND
RECOVERY PROGRAM (YCRRP) OF THE DEPARTMENT OF
TOURISM (DOT) FROM LEYTE GEOTHERMAL POWER FIELD
IN BARANGAY TONGONAN, ORMOC CITY TO THE
CABINTAN ADVENTURE AND FARM SITES IN BARANGAY
CABINTAN, ORMOC CITY.**

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated June 13, 2018, requesting therein for the passage of a Sanggunian resolution approving the site replacement in reference to the Yolanda Comprehensive Rehabilitation and Recovery Program (YCRRP) of the Department of Tourism;

WHEREAS, Section 2 of RA 10121 states that it shall be the policy of the State to recognize and strengthen the capacities of LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters and to provide maximum care, assistance, and services to individuals and families affected by disaster, implement emergency rehabilitation projects to lessen the impact of disaster, and facilitate resumption of normal social and economic activities;

WHEREAS, through the Yolanda Comprehensive Rehabilitation and Recovery Program (YCRRP), the Department of Tourism provided assistance to local government units to rehabilitate their tourism infrastructures damaged by Super Typhoon Yolanda so that economic activities in these sites could resume;

WHEREAS, from the results of the post damage assessment, 17 sites in the Province of Leyte were identified and recommended for rehabilitation and further development and these included Lake Danao Natural Park and Leyte Geothermal Power Field both from Ormoc City;

WHEREAS, during the initial assessment of the consultants, it was found out that in addition to the fact that Leyte Geothermal Power Field is privately owned, the power plants and other major facilities were also damaged by the July 2017 earthquake and this prompted the Ormoc City Government to recommend an alternate tourism site for the YCRRP;

WHEREAS, Barangay Cabintan is recommended as the alternate site on the basis of its potentials for tourism development and the going projects boosting the tourism sites in the said barangay;

WHEREAS, upon close and thorough review, the Committee on Tourism finds that the request is not contrary to law and existing contracts, and the aim is beneficial and advantageous to Ormoc City and to its people considering that the rehabilitation and further development of Lake Danao Natural Park and Cabintan Adventure and Farm Sites will drive economic recovery and growth so therefore most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee on Tourism, severally seconded by SP Members John Eulalio Nepomuceno O. Aparis II, Gregorio G. Yrastorza III, Tomas R. Serafica and Jasper C. Yerro; be


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION APPROVING THE SITE REPLACEMENT FOR THE YOLANDA COMPREHENSIVE REHABILITATION AND RECOVERY PROGRAM (YCRRP) OF THE DEPARTMENT OF TOURISM (DOT) FROM LEYTE GEOTHERMAL POWER FIELD IN BARANGAY TONGONAN, ORMOC CITY TO THE CABINTAN ADVENTURE AND FARM SITES IN BARANGAY CABINTAN, ORMOC CITY;
