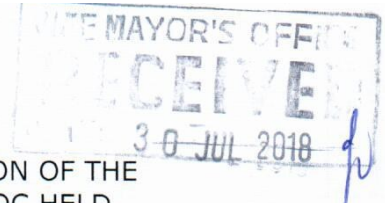

RESOLUTION NO. 2018-177

A RESOLUTION AMENDING SP RESOLUTION NO. 2018-144 SERIES 2018 ENTITLED: "A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND- FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF - FA TO LGUs) AND AFFIRMING THAT SUCH PROGRAMS/PROJECTS ARE PART OF THE DULY APPROVED CY 2018 ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY" BY STATING THAT THE LIST OF PRIORITY PROGRAMS/PROJECTS SUBJECT OF THE AFOREMENTIONED RESOLUTION ARE PART OF THE APPROVED ANNUAL INVESTMENT PROGRAM OF CY 2018 AND THE APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM OF CY 2017-2020.

WHEREAS, this Sanggunian passed Sangguniang Panlungsod (SP) Resolution No. 2018-144 on June 21, 2018 entitled: "A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND- FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF - FA TO LGUs) AND AFFIRMING THAT SUCH PROGRAMS/PROJECTS ARE PART OF THE DULY APPROVED CY 2018 ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY", which was requested pursuant

to the requirements set under Item 3.0 of the Local Budget Circular (LBC) No. 117 dated February 5, 2018 with the subject, "Guidelines on the Release and Utilization of the Local Government Support fund – Financial Assistance to Local Government Units(LGSF-FA to LGUs) in the FY 2018 General Appropriations Act(GAA), Republic Act(RA) No. 10964", a copy of said resolution is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, an endorsement dated July 17, 2018 was forwarded to this august Body from the Office of the City Mayor, requesting for amendment of SP Resolution No. 2018-144 for it to state that the priority projects subject of the aforementioned Resolution are part of the Annual Investment Program of CY 2018 and the approved Local Development Investment Program of CY 2017-2020;

WHEREAS, one of the requirements set by the Department of Budget and Management (DBM) under Local Budget Circular No. 117 is that the list of priority programs/projects of the Local Government Unit should form part of the approved Annual Investment Program and approved Local Development Investment Program;

WHEREAS, under SP Resolution No. 2018-144, the list of priority programs/projects of the Local Government of Unit of Ormoc was not stated as part of the duly approved Local Development Investment Program;

WHEREAS, on a committee meeting conducted last July 20, 2018 by the Committee on Infrastructure and Development, it was confirmed by the City Planning and Development Office that the list of priority programs/projects formed part of the approved Local Development Investment Program of CY 2017-2020;

WHEREAS, after clearly finding said request of the Honorable City Mayor to be in order and bequeathed with merit and favor, this Sanggunian, hence, lends its full support and favorable consideration to the same;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Serafica, Vice- Chairman of the Committee on Infrastructure Development, severally seconded by SP Members Vincent L. Rama, Gregorio G. Yrastorza III, Nolito M. Quiang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Melbur N. Melgazo and Jasper C. Yerro; Be it
