# RESOLUTION NO. 2018-184

A RESOLUTION GRANTING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC) WITH DEPARMENT OF AGRICULTURE-REGIONAL FIELD OFFICE VIII (DA REO VIII), FOR THE PROVISION OF ONE (1) VALT CASSAVA PULVERIZER UNDER THE DA-CORN PROGRAM/CASSAVA PROJECT 2018.

WHEREAS, the  $14^{ ext{TH}}$  Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on July 10, 2018 for consideration of a Memorandum of Agreement (MOA) to be entered into by the Local Government Unit of Ormoc City (LGU-ORMOC) and the Department of Agriculture-Regional Field Office VIII (DA-RFO VIII), represented by its Regional Executive Director, ATTY. CIPRIANO G. SANTIAGO, CESO III, a copy of the final MOA is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Department of Agriculture (DA), through its Regional Field Office, is implementing the Corn Program/Cassava Project in pursuit of food security and poverty alleviation in the agricultural sector as envisioned under Republic Act No. 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) of 1995;

WHEREAS, one of the objectives of the AFMA is to modernize the agricultural and fisheries sectors by transforming them from a resourced-based to a technology-based industry;

WHEREAS, the DA-RFO VIII is mandated to provide support and assistance to the local government units in the pursuit for agricultural development and the promotion of farmer's welfare;

WHEREAS, one of the components of the Corn Program/Cassava Project is the provision of farm machineries and equipment to qualified farm organizations and/or local government units;

WHEREAS, LGU-ORMOC is proposing and has signified its intention to avail of one(1) unit Cassava Pulverizer through full grant financing scheme from the DA;

WHEREAS, this MOA shall involve the provision of one (1) unit Cassava Pulverizer, through a full grant scheme from DA-RFO VIII to LGU-ORMOC in which the direct beneficiaries shall be the cassava farmers of Ormoc City;

WHEREAS, the provision of Cassava Pulverizer will help in the modernization of farm operations by mechanizing farming activities and contribution to the cassava production in Ormoc City;

WHEREAS, after review of the draft MOA by the City Legal Officer, Atty. Jasper M. Lucero, he finds it in order, not detrimental to the interest of the City, not contrary to law, morals and public policy recommending the approval of the aforementioned MOA, and that a Sangguniang Panlungsod Resolution be secured for the Authority of the Mayor to sign the same, a copy of the letter is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, upon close and thorough review, this Sanggunian finds the aforementioned request by the City Mayor advantageous and for the best interest of the City and its inhabitants, especially the cassava farmers;

NOW THEREFORE, on motion of SP Member Serafica, Chairman of the Committee on Agriculture, Fisheries and Agrarian Reform, severally seconded by SP Members Vincent L. Rama. Notito M. Quilang, Lea Doris C. Villar, Melbur N. Melgazo, Jasper C. Yerro and Gregorio G. Yrastorza III; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY WITH THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE VIII, FOR THE PROVISION OF ONE(1) UNIT CASSAVA PULVERIZER UNDER THE DA-CORN PROGRAM /CASSAVA PROJECT 2018;

#### MEMORANDUM OF AGREEMENT

# KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is made and entered into by and between:

The DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OFFICE 8, a national government agency, with office address at Kanhuraw Hill, Tacloban City, represented by Regional Executive Director ATTY. CIPRIANO G. SANTIAGO, CESO 137, hereina/ter referred to as "DA-RFO 8".

and

The CITY OF ORMOC, when office address at Ormoc City, Leve represented by City Mayor HON. RICHARD I. GOMEZ, hereinafter referred to as "CLGU ORMOC".

#### WITHESSETH:

WHEREAS, the Department of Agriculture (DA), through its Regional Field Office 8 (RFO 8), is implementing the Corn Program/Cassava Project in pursuit of poverty alleviation in the agricultural sector and food security as envisioned under Republic Act 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) o. 1995;

WHEREAS, one of the objectives of the AFMA is to modernize the agricultural and fisheries sectors by mansforming them from a resourced based to a technology-based industry;

WHEREAS, the DA-REOS is conducted to provide support and assistance to the local government units in the conjugate for agricultural development and the promotion of fam.ers' welfare;

WHEREAS, one of the components of the Corn Program/Cassava Project is the provision of farm machineries and equipment to qualified farmer organizations and/or local government units;

WHEREAS, said program air is to transform cassava farm clusters into modern agribusiness system thru medianized farming;

WHERIAS, CLGU ORMOC proposing and has signified its intention to avail of one (1) unit CASSAVA FL. VERIZER through a full grant financing scheme from the DA, hereinafter religined to as "Project";

whereas, the provision of Cassava Pulverizer will help in the modernization of farm operations by mechanizing farming activities and contributing to the cassava production in Ormoc City, Leyte;

THEREFORE, for and in consideration of the foregoing premises, the parties hereto agree to jointly uncertake the said Project under the following terms and conditions:

#### I. GENERAL CONDITIONS

- A. This Agreement shall involve the provision of one (1) unit CASSAVA PULMERIZER by the DA-RFO 8 to CLGU ORFOCE through a full grant financing scheme.
- B. The direct beneficiaries of this Agreement shall be the caseava farmers of Ormoc City, Leyte

## II. OBLIGATIONS OF THE PARTIES

#### A. The DA-RFO 8 shall:

- Procure one (1) unit CASSAVA PULVERIZER under the Corn Program/Cassava Project Fund (CO-Grant) amounting to Sixty Thousand Pesos (Php60,000.00) in accordance with RA 9184, otherwise known as the New Government Procurement Act and its Implementing Rules and Regulations.
- 2. Turn-over the procured CASSAVA PULVEDIZER to CLGU ORMO upon the latter's signature in the IR and ARE.
- 3. Train the CLGU ORMOC on the operation and maintenance of the unit through the Regional Comprogram Management Unit (RCPMU) and the Regional Agriculture Engineering Division (RAED).
- 4. Ensure that the goals and objectives of the project achieved through periodic monitoring and evaluation.
- Provide other forms of technical assistance whenever necessary and upon request by the **CLGU ORMOC**.

### B. CLGU ORNOC shall:

- 1. Acknowledge Screipt of the Cassava Pulverizer from the DA-RFO 8 arough an Invoice Receipt (IR) and Acknowledgment Receipt of Equipment (ARE).
- Ensure that the unit is used primarily in the cassava cluster areas of the province for cassava related activities.
- Provide the manpower necessary for the operation and management of the unit.
- Ensure that the unit is secured and sheltered from sunlight, rain and other adverse conditions when not in use.
- Secure a comprehensive insurance coverage for the equipment from the Philippine Crop Insurance Crop (PCIC) for a period of ten (10) years from acceptance of

- Shoulder the repair and maintenance cost of the equipment upon expiration of the warranty period of the manufacturer.
- 7. Maintain a parate and detailed logbook/record of the equipment operations and whenever requested by the monitoring pam/representatives, allow them complete access to the same.
- Submit quarterly status and performance reports.
- Lend the unit for quick-response activities for the rehabilitation of areas struck by calamity when requested by the DA-RFO 8.

#### III. OTHER COVENANTS

- A. This Agreement shall take effect upon signing by the parties and shall be in force and effect until the satisfactory fulfillment of the herein terms and conditions.
- B. Any amendment or supplement to this Agreement shall be binding only upon the written consent of both parties.
- C. Non-compliance to the herein terms and conditions shall be a ground for the rescission of this Agreement.
- D. Any dispute arising from this Agreement shall be submitted or arbitration in accordance with the provisions of RA 876 or other modes of speedy and amicable dispute resolution prior to court action.
