A RESOLUTION GRANTING THE CITY MAYOR RICHARD I.
GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF
AGREEMENT FOR AND IN BEHALF OF THE LOCAL
GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC) WITH
DEPARMENT OF AGRICULTURE-REGIONAL FIELD OFFICE
VIII (DA-RFO VIII), FOR THE PROVISION OF ONE (1)
UNIT COMPACT CORN MILL UNDER THE DA-CORN
PROGRAM/CASSAVA PROJECT 2018.

WHEREAS, the 14<sup>TH</sup> Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on July 10, 2018 for consideration of a Memorandum of Agreement (MOA) to be entered into by the Local Government Unit of Ormoc City (LGU-ORMOC) and the Department of Agriculture-Regional Field Office VIII (DA-RFO VIII), represented by its Regional Executive Director, ATTY. CIPRIANO G. SANTIAGO, CESO III, a copy of the final MOA is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Department of Agriculture (DA), through its Regional Field Office, is implementing the Corn Program/Cassava Project in pursuit of food security and poverty alleviation in the agricultural sector as envisioned under Republic Act No. 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) of 1995;

WHEREAS, LGU-ORMOC is proposing and has signified its intention to avail of one(1) unit Compact Corn Mill through full grant financing scheme from the DA;

WHEREAS, this MOA shall involve the provision of one (1) unit Compact Corn Mill, through a full grant scheme from DA-RFO VIII to LGU-ORMOC in which the direct beneficiaries shall be the corn farmers of Ormoc City;

WHEREAS, the provision of Compact Corn Mill will help in the modernization of farm operations by mechanizing farming activities and contribution to the corn production in Ormoc City;

WHEREAS, after review of the draft MOA by the City Legal Officer, Atty. Jasper M. Lucero, he finds it in order, not detrimental to the interest of the City, not contrary to law, morals and public policy recommending the approval of the aforementioned MOA, and that a Sangguniang Panlungsod Resolution be secured for the Authority of the Mayor to sign the same, a copy of the letter is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, upon close and thorough review, this Sanggunian finds the aforementioned request by the City Mayor advantageous and for the best interest of the City and its inhabitants, especially the corn farmers;

The DEPARTMENT OF AGRICULTURE - REGIONAL FIELD OF THE CE 8, a national government agency, with office address at Kanhuraw Hill, Tacloban City, represented by Regional Executive Director ATTY, CIPRIANO G. SANTIAGO, CESCOTTI, here nafter referred to as "DA-RFO 8".

The CITY OF ORMOC, with office address at Ormoc City, Lette represented by City Mayor HON. RICHARD I. GOMEZ, here mafter referred to as "CLGU ORMOC",

WHEREAS, the Department of Agriculture (DA), through its Regi Field Office 8 (RFO 8), is implementing the Corn Program/Cassava Project in pursuit of poverty alloviation in the agricultural sector and food security as envisioned under Republic Act, 8435, otherwise known as the Agriculture and Fisheries Modernizador Act (AFMA) 1995;

WHEREAS, one of the objectives of the AFMA is to modernize the agricultural and fisheries sectors by transforming them from a resourced-based to a technology-based industry;

WHEREAS, the DA-RFOS is maindated to provide support and assistance to the local government units in their pursuit for agricultural development 4.31 the promotion of faritiers' welfare;

WHEREAS, one of the components of the Corn Program/Cassava Prof. t is the provision of farm machineries and equipment to qualified fare or organizations and/ r local government units;

WHEREAS, and program was to transform corn farm clusters into modern agricusiness system thru men lanized farming;

WHIRE AS CLGU OR MOC Proposing and has signified its intention to avail of one (1) unt COMPACT & RN MILL through a full grant ficancing scheme from the DA, heremafter reinted to as "Project";

WHENEAS, the provision of Compact Corn Mill will help in modernization of form operations by mechanizing farming activities contributing to the corn production in Ormoc City, Leyte;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agree to jointly undertake the said Project under the following terms and conditions:

Page 1 eff

#### I. GENERAL CONDITIONS

- A. This Agreement shall involve the provision of one (1) duit COMPACT CORN MILL by the DA-RFO 8 to CLGU ORMOC through a full grant financing scheme.
- B. The direct beneficiaries of this Agreement shall be the corn fancers of Ormoo City, Leyte

#### II. OBLIGATIONS OF THE PARTIES

# A. The DA-RFO 8 shall:

- 1. Procure one (1) unit COMPACT CORN MILE under the Corn Program/Cassava Project Fund (CO-Grave) amounting to Four Hundred Fifty Thousand Follows (Php450,000.00) in accordance with RA 9184, otherwise known as the New Government Procurement Act and Implementing Rules and Regulations.
- 2. Turn-over the procured COMPACT CORN MILL to CL GU ORMOC upon the latter's signature in the IR and ARE.
- Train the CGU ORMOC on the operation and maintenance of the unit through the Regional Corp. Program Management Unit (RCPMU) and the Regional Agriculture Engineering Division (RAED).
- Ensure that the goals and objectives of the project achieved through periodic monitoring and evaluation.
- 5. Provide other forms of technical assistance whenever necessary and upon request by the CLGU ORMOC.

#### B. CLGU DRMOC shall:

- 1. Acknowledge recipt of the Compact Corn Mill from the DA RFO 8 Arough an Invoice Receipt (IR) and Acknowledge Receipt of Equipment (ARE).
- 2 Ensure that the unit is used primarily in the corn cluster areas of the province for corn related activities.
- Provide the manpower necessary for the operation as management of the unit.
- Ensure that the unit is secured and sheltered from sunlight, rain and other adverse conditions when not in use.
- 5. Secure a comprehensive insurance coverage for the equipment from the Philippine Crop Insurance Crop (PCIC) for a period of ten (10) years from acceptance of

- Shoulder the repair and maintenance cost of the equipment upon expiration of the warranty period of the manufacturer.
- 7. Maintain a 9 parate and detailed logbook/record of the equipment operations and whenever requested by the monitoring fram/representatives, allow them complete access to the same.
- 8. Submit quarterly status and performance reports.
- Lend the unit for quick-response activities for the rehabilitation of areas struck by calamity when requested by the DA-RFO 8.

# III. OTHER COVENANTS

- A. This Agreement shall take effect upon signing by the parties and shall be in force and effect until the satisfactory fulfillment of the herein terms and conditions.
- B. Any amendment or supplement to this Agreement shall be binding only upon the written consent of both parties.
- C. Non-compliance to the herein terms and conditions shall be a ground for the rescission of this Agreement.
- D. Any dispute arising from this Agreement shall be submitted for arbitration in accordance with the provisions of RA 876 or other modes of speedy and amicable dispute resolution prior to court action.
