GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF

AGREEMENT FOR AND IN BEHALF OF THE LOCAL

SOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC) WITH

NEPARMENT OF AGRICULTURE-REGIONAL FIELD OFFICE

VIII (DA-RFO VIII), FOR THE PROVISION OF ONE (1)

UNIT HERMETIC COCOON UNDER THE DA - CORN

PROGRAM /CASSAVA PROJECT 2018.

WHEREAS, the 14TH Sangguniang Panlungsod ng Ormoc received an endorsement letter from the Office of the City Mayor on July 10, 2018 for consideration of a Memorandum of Agreement (MOA) to be entered into by the Local Government Unit of Ormoc City (LGU-ORMOC) and the Department of Agriculture-Regional Field Office VIII (DA-RFO VIII), represented by its Regional Executive Director, ATTY. CIPRIANO G. SANTIAGO, CESO III, a copy of the final MOA is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Department of Agriculture (DA), through its Regional Field Office, is implementing the Corn Program/Cassava Project in pursuit of food security and poverty alleviation in the agricultural sector as envisioned under Republic Act No. 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) of 1995;

WHEREAS, one of the objectives of the AFMA is to modernize the agricultural and fisheries sectors by transforming them from a resourced-based to a technology-based industry;

WHEREAS, the DA-RFO VIII is mandated to provide support and assistance to the local government units in the pursuit for agricultural development and the promotion of farmer's welfare;

WHEREAS, one of the components of the Corn Program/ Cassava Project is the provision of farm machineries and equipment to qualified farm organizations and/or local government units;

WHEREAS, LGU-ORMOC is proposing and has signified its intention to avail of one(1) unit Hermetic Cocoon through full grant financing scheme from the DA;

WHEREAS, this MOA shall involve the provision of one (1) unit Hermetic Cocoon, through a full grant scheme from DA-RFO VIII to LGU-ORMOC in which the direct beneficiaries shall be the corn farmers of Ormoc City;

WHEREAS, the provision of Hermetic Cocoon will help in the modernization of farm operations by mechanizing farming activities and contribution to the corp production in Ormoc City;

WHEREAS, after review of the draft MOA by the City Legal Officer, Atty. Jasper M. Lucero, he finds it in order, not detrimental to the interest of the City, not contrary to law, morals and public policy recommending the approval of the aforementioned MOA, and that a Sangguniang Panlungsod Resolution be secured for the Authority of the Mayor to sign the same, a copy of the letter is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, upon close and thorough review, this Sanggunian finds the aforementioned request by the City Mayor advantageous and for the best interest of the City and its inhabitants, especially the corn farmers;

NOW THEREFORE, on motion of SP Member Serafica, Chairman of the Committee on Agriculture, Fisheries and Agrarian Reform, severally seconded by SP Members Vincent L. Rama, Gregorio G. Yrastorza III, Nolito M. Quilang, Lea Doris C. Villar, Melbur N. Melgazo and Jasper C. Yerro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY WITH THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE VIII, FOR THE PROVISION OF ONE (1) UNIT HERMETIC COCOON UNDER THE DA-CORN PROGRAM /CASSAVA PROJECT 2018;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandus, of Agreement is made and entered into by and between:

The DEPARTMENT OF AGN JULTURE - REGIONAL FIELD OFFICE 8, a national government agency, we office address at Kanhuraw Hill, Taclobal City, represented by Regional Executive Director ATTY. CEPRIANO 45. SANTIAGO, CESO III, hereinafter referred to as "DA-RFO 8",

and

The CITY OF ORMOC, with office address at Ormoc City, Leyte represented by City Mayor HON. RICHARD I. GOMEZ, hereinafter referred to as "CLGU ORMOC",

WITHESSETH:

WHEREAS, the Department of Agriculture (DA), through its Regional Field Office 8 (RFO S), is implementing the Corn Program/Cassava Project on pursuit of poverty atteviation in the agricultural sector and food security as envisioned under Republic Act 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) of 1995;

WHEREAS, one of the objectives of the AFMA is to modernize the agricultural and fisheries sectors by transforming them from a resourced-based to a technology-based industry;

WHEREAS, the DA-RFOS is mandated to provide support and assistance to the local government units in their pursuit for agricultural development of the promotion of farmers' welfare;

WHEREAS, one of the components of the Corp Program/Cassava Project is the provision of term machine as and equipment to qualified farmer organizations and/or local government units;

WHEREAS, said program aims to transform corn farm clusters into modern agribusiness system thru mechanized farming;

WHEREAS CLGU ORMOC is proposing and has signified its intention to avail of one (1) unit HERMETIC COCOON through a full grant financing scheme from the DA, hereinafter referred to as "Project";

whereas, the provision of Hermetic Cocoon will help in the modernization of farm operations by mechanizing farming activities and contributing to the core production in armoc City, Leyte;

NOW THEREFORE, for and a consideration of the foregoing premises, the parties hereto agone to jointly encourage the said Project under the following terms and conditions:

I. GENERAL CONDITIONS

- A. This Agreement of di involve the provision of one (1) with HERMETIC CO. ON by the DA-RFO 0 to CLOU OCHOC/ORMOC ATY CORN CLUSTER through a full great financing scheme.
- B. The direct beneficiaries of this Agreement shall be the members of ORMAC CITY CORN CLUSTER and the corn farmers of Ormac City, Leyte

II. OBLIGATIONS OF THE PARTIES

A. The DA-RFO 8 shall:

- 1. Procure eng 1) unit HERMETIC COCOON under the Corn Program/Cassava Project Fund (CO-Grand) amounting to One Hundred Forty Nine Thousand Nine Hundred Fifty esos (Php149,950.00) in accordance with RA 9184, at a wise known as the New Governance Procurement act and its Implementing Rules and Regulations.
- 2. Turn-over the procured HERMETIC COCOON to CLOW ORMOC upon the latter's signature in the IR and ARE.
- 3. Train the CLGU ORMOC on the operation and maintenance of the unit through the Regional Cornerogram Management Unit (RCPMU) and the Regional Agriculture Engineering Division (RAED).
- 4. Ensure that the goals and objectives of the project are achieved through periodic monitoring and evaluation.
- 5. Provide other forms of technical assistance whenever necessary and pon request by the CLGU ORMOC.

R. The CLGU ORMOC shall:

- 1. Acknowledge receipt of the Hermetic Cocoon from the DA-RFO 8 through an Invoice Receipt (IR) and Acknowledgment Receipt of Equipment (ARE).
- 2. Ensure that the unit is used primarily in the corn cluster areas of the province for corn related activities.
- 3. Provide the mappower necessary for the operation and management of the unit.
- Ensure that the unit is secured and sheltered from sunlight, rain and other adverse conditions when not in use.
- 5. Secure a comprehensive insurance coverage for the

- 9. Lend the wat for quick-response activities for the rehabilitation of areas struck by calamity when requested by the DA-RE-18.

III. OTHER COVENANTS

- A. This Agreement shall take effect upon signing by the parties and shall be in force and effect until the satisfactory fulfillment of the herein terms and conditions.
- B. Any amendment or supplement to this Agreement shall be binding only upon the written consent of both parties.
- C. Non-compliance to the herein terms and conditions shall be a ground for the responsion of this Agreement.
- D. Any dispute arising from this Agreement shall be submitted for arbitration in accordance with the provisions of RA 876 or other modes of speedy and amicable dispute resolution prior to court action.
