SEPARATE APPLICATIONS FOR ACCREDITATION WITH
THE LOCAL GOVERNMENT UNIT OF ORMOC, IN
ACCORDANCE WITH THE PROVISIONS OF ORDINANCE
NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING
CIVIL SOCIETY ORGANIZATIONS, TO WIT:

- 2. GUINTIQUI AN INTEGRATED FARMER'S ASSOCIATION (GIFA)
- 3. ORMOC BUS AND JEEPNEY TERMINAL VENDORS ASSOCIATION (OBAJTVA)
- 4. SIDLAK-CHRISTIAN CHILDREN FUND SAVINGS AND CREDIT COOPERATIVE (SCSCC)

WHEREAS, this Sanggunian received the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

- 1. Airport Farmers Association (AFA)
- 2. Guintigui-an Integrated Farmer's Association (GIFA)
- 3. Ormoc Bus and Jeepney Terminal Vendors Association (OBAJTVA)
- 4. Sidlak-Christian Children Fund Savings And Credit Cooperative (SCSCC)

WHEREAS, Airport Farmers Association (AFA), a duly registered organization under Department of Labor and Employment (DOLE), organized into a legitimate farmers association to improve their standard of living and enhance the general welfare of its members. Among the association's purpose is to develop a sustainable livelihood with effective and innovative way of agriculture production and farming;

WHEREAS, Guintigui-an Integrated Farmer's Association (GIFA), is a newly organized association of farmers and registered with the Department of Labor and Employment (DOLE). Among its objective is to establish mutual aid and protection as well as to uplift the economic condition of its members;

WHEREAS, Ormoc Bus and Jeepney Terminal Vendors Association (OBAJTVA), is a local group of vendors in Ormoc City Terminal seeking for accreditation to be recognized as one of the accredited associations of LGU Ormoc. Among their goals is to participate in events and activities of the Local Government and support the city in its endeavor to have a clean and organized Terminal accessible to commuters from different places. Further, OBAJTVA is a duly registered association by the Department of Labor and Employment (DOLE);

WHEREAS, Sidlak-Christian Children Fund Savings and Credit Cooperative (SCSCC), is a Credit Cooperative composed of residents from different barangays who wants to attain increased income, savings, investments, productivity, and purchasing power, and promote among themselves equitable distribution of net surplus through maximum utilization of economies of scale, cost-sharing and risk-sharing. SCSCC is registered with the Cooperative Development Authority (CDA) and a member of the Ormoc City Cooperative Development Council (OCCDC);

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforementioned applications, find that the same are in order, and the purposes of the sought accreditation is to promote the moral, social and economic development among its members through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;
