A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), AS DONEE, TO ACCEPT AND SIGN THE DEED OF DONATION WITH FRANCISCO R. SERAFICA, JR., AS DONOR OVER A PORTION OF A PARCEL OF LAND LOCATED AT BARANGAY VALENCIA, THIS CITY EQUIVALENT TO AN AREA OF TWO THOUSAND EIGHT HUNDRED FIFTY-FIVE (2,855) SQUARE METERS.

WHEREAS, an Indorsement was forwarded to this august Body from the Office of the City Mayor dated July 30, 2018, requesting this august Body for the issuance of a Resolution granting authority to the City Mayor to accept and sign the attached DEED OF DONATION executed by Francisco R. Serafica, Jr., as Donor, in favor of the Local Government Unit of Ormoc City (LGU-Ormoc), as Donee, copies of the final Deed of Donation (Deed) and its annex are hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, in an Indorsement dated July 25, 2018, the City Legal Officer respectfully forwarded to the Office of the City Mayor, the draft Deed by Francisco Serafica, Jr. in favor of LGU-Ormoc, further requesting that appropriate and immediate communication be made to the SP requesting the latter for authority of the Mayor to sign and accept the Deed of Donation, a copy of the said Indorsement is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, the Donor is the absolute owner of a parcel of land situated in Brgy. Valencia, Ormoc City more particularly described as follows:

"A parcel of land, Lot No. 8403-B of the subdivision plan Psd-37062, being a portion of Lot 8403, Ormoc Cadastre. Situated in Brgy. Valencia, Ormoc City, containing an area of THIRTY FOUR THOUSAND AND THIRTY FOUR (34,034) SQUARE METERS and covered by Transfer Certificate of Title No. 22143, of the Registry of Deeds of Ormoc City;"

WHEREAS, Mr. Francisco R. Serafica, for and in consideration of pure liberality, executed a Deed in favor of LGU-Ormoc, presents, transfers and conveys, unto LGU-Ormoc, a portion of afore-described parcel of land equivalent to an area of TWO THOUSAND EIGHT HUNDRED FIFTY-FIVE (2,855) SQUARE METERS which will be used by the latter for a public road, which portion is designated as Lot 8403-B-2 on a lot sketch plan attached to a copy of the Deed, a copy of the Transfer Certificate of Title are hereto attached as Annex "C" and made an integral part hereof;

WHEREAS, this august Body believes that said donation is done in good faith, is extremely beneficial to the Barangay, in particular, and to the City, in general, for the aforementioned donation purpose, and not made for the purpose of derivating the Donor's creditors, having reserved for himself enough and sufficient property to meet his obligations;

WHEREAS, the said donated property shall be considered as forming part of City properties for public use pursuant to the applicable provisions of the Civil Code;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor finds that it is to the best interest of the City and advantageous to the same, and further deems it proper and meritorious to authorize the City Mayor to sign the Deed of Donation and accept the said property for future use located at Barangay Valencia, this City;






