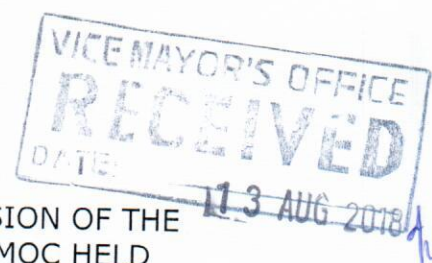

RESOLUTION NO. 2018-205

**A RESOLUTION AMENDING SECTION 1 OF RULE VI AND
ANNEX A OF SANGGUNIANG PANLUNGSOD NG ORMOC
RESOLUTION NUMBER 2016-001, ENTITLED: "A
RESOLUTION ADOPTING THE INTERNAL RULES OF
PROCEDURE OF THE 14TH SANGGUNIANG PANLUNGSOD
NG ORMOC", AS AMENDED.**

WHEREAS, this Sanggunian passed Sangguniang Panlungsod (SP) Resolution No. 2018-164 on July 05, 2018 entitled: "A RESOLUTION ACCEPTING WITH REGRETS THE RESIGNATION OF HONORABLE SP MEMBER ROLANDO M. VILLASENCIO AS MEMBER OF THE FOURTEENTH SANGGUNIANG PANLUNGSOD" which manifested its acceptance and acceded to the resignation of SP Member Rolando M. Villasencio as Member of the 14th Sangguniang Panlungsod, for purposes of good governance;

WHEREAS, in light of said resignation, there is a need, therefore, for purposes of efficient supervision and administration of the City, to further amend and reorganize the Sanggunian Districts in order to distribute the assigned Barangays of former SP Member Rolando M. Villasencio to the incumbent Regular SP Members by amending Rule VI and Annex A of SP Resolution No. 2016-001, entitled: "A Resolution Adopting the Internal Rules of Procedure of the 14th Sangguniang Panlungsod ng Ormoc", as amended;

WHEREAS, Section 1 of Rule VI of said amended Resolution shall now read as follows:

"RULE VI – ORGANIZATION OF SANGGUNIAN DISTRICTS

SECTION 1. - For purposes of efficient supervision and administration of the City, there are hereby created TEN (10) SANGGUNIAN DISTRICTS, the composition of which shall be subject to change at any time upon approval of the majority vote of the Sanggunian members. Until revised, the division of the different barangays comprising each Sanggunian District and the Chairmanship or representation of each District as approved by the Sanggunian Members are hereto attached and marked as Annex "A".

PROVIDED, HOWEVER, that the Chairmanship, charge or representation of the Districts herein created may be reshuffled at any time upon approval of the majority vote of the Sanggunian Members."

WHEREAS, in view of the foregoing, the reorganization of the Sanggunian Districts would also necessarily entail the amendment of "Annex A" of the said Rules as well, a copy of the amendment is hereto attached and made an integral part hereof;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Internal Rules of Procedure, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno G. Aparis II, Lea Doris C. Villar and Esteban V. Laurente; be it


