A RESOLUTION GRANTING THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR THE AUTHORITY TO ACCEPT AND SIGN A DEED OF DONATION BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH RUFINO BRODETH AND CO., INCORPORATED, AS DONOR, OF TWELVE (12) PIECES BRAND NEW PHILIPS ESSENTIAL SMARTBRIGHT LED FLOODLIGHT IN FAVOR OF LGU-ORMOC AS DONEE.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Administrator Vincent L. Emma addressed to the Vice Mayor Leo Carmelo L. Locsin, Jr, City Vice Mayor & Presiding Officer of the 14th Sangguniang Panlungsod ng Ormoc dated August 7, 2018 requesting for the issuance of a resolution granting Mayor Richard I. Gomez the authority to enter into and sign the Deed of Donation in favor of the Local Government Unit of Ormoc (LGU-Ormoc) with Rufino Brodeth and Co., Incorporated as Donor of Twelve (12) pieces Brand New Philips, Essential Smartbright, BVP161 LED90/CW 100W 220-240V WB GREY GM, further requesting that this matter be treated as "urgent", a copy of said Deed of Donation is hereto attached and made an integral part thereof;

WHEREAS, RUFINO BRODETH AND CO., INCORPORATED is a duly registered corporation with postal address at corner Juan Luna & Burgos Streets, Sabang, Ormoc City, Leyte and is the owner of twelve (12) pieces Philips Essential SmartBright LED Floodlight, more particularly described as follows:

WHEREAS, said Deed of Donation provides that the LGU-Ormoc, as DONEE, shall install all the 12 Floodlights at the City's Tennis Court Facility at the Government Center along corners Dalingdingan Street and C.S. Mendola Street, this City;

WHEREAS, the said donated properties shall be considered as forming part of City properties for public use pursuant to the applicable provisions of the Civil Code;

WHEREAS, LGU-Ormoc expresses its gratitude and utmost appreciation for the generosity and openhandedness of the Donor;

WHEREFORE, after a thorough examination of the aforementioned request by the City Mayor, this Sanggunian finds that the object and purposes for which the donation is made are noble, and that the same is entered into for the best interests of the City and her constituents, and therefore, most deserving of this august Body's full support, endorsement and prompt affirmative consideration to the same;

NOW, THEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Laws and Ordinances, severally seconded by SP Members Mario M. Rodriguez, Lea Doris C. Villar, Esteban V. Laurente and John Eulalio Nepomuceno O. Aparis II; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR THE AUTHORITY TO ACCEPT AND SIGN A DEED OF DONATION BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH RUFINO BRODETH AND CO., INCORPORATED, AS DONOR, OF TWELVE (12) PIECES BRAND NEW PHILIPS ESSENTIAL SMARTBRIGHT LED FLOODLIGHT IN FAVOR OF LGU-ORMOC AS DONEE;


ADOPTED, August 16, 2018.




