**A RESOLUTION AMENDING ANNEX "A" OF SP RESOLUTION NO. 2018 - 144, ENTITLED: "A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT OF ORMOC (LGU-ORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND - FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF - FA TO LGUs) AND AFFIRMING THAT SUCH PROGRAMS/PROJECTS ARE PART OF THE DULY APPROVED CY 2018 ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY."**

WHEREAS, the Office of the City Mayor forwarded to the Fourteenth Sangguniang Panlungsod an extremely urgent Indorsement dated August 8, 2018 in relation to SP Resolution No. 2018-144, requesting for the amendment of Annex "A" of said issuance;

WHEREAS, to recall, this august Body has passed and approved SP Resolution No. 2018-144, Entitled: "A RESOLUTION EARNESTLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THE LIST OF PRIORITY PROGRAMS/PROJECTS OF THE LOCAL GOVERNMENT OF ORMOC (LGU-ORMOC) TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND - FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF - FA TO LGUs) AND AFFIRMING THAT SUCH PROGRAMS/PROJECTS ARE PART OF THE DULY APPROVED CY 2018 ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY.";



WHEREAS, attached to SP Resolution No. 2018-144 was the list of priority programs and projects endorsed to Department of Budget and Management (DBM) to be funded under LGSF-FA to LGUs marked as Annex "A" thereof;

WHEREAS, in reference to the said list of Projects (Annex A) there was a provision for the Construction of Roundabout in the amount of Four Million Pesos (P4,000,000.00) which is the object of the proposed amendment;

WHEREAS, the City Mayor believes that there is an immense need to provide more funding on the program-Hospitalization to Indigent Patients hence, the need to amend the said list of projects marked as Annex "A" of SP Resolution 2018-144 by taking out the project-Construction of Roundabout from the list and further adding its proposed allocation of Four Million Pesos (P4,000,000.00) to the program - Hospitalization to Indigent Patients for a total allocation of Six Million Three Hundred Thousand Pesos (P6,300,000.00);

WHEREAS, in view thereof, an updated list of priority programs/projects to be funded under the LGSF - FA to LGUs is hereto attached as amended Annex "A", and made an integral part of this resolution;

WHEREAS, this august body finds that the proposed amendment is indeed vital for the effective and efficient provision of health services to the Ormocanon people which is one of the primary thrusts of the administration therefore, most deserving of prompt favorable support;

WHEREFORE, on motion of SP Member Esteban V. Laurente, Chairman, Committee on Infrastructure Development, jointly seconded by SP Members Tomas R. Serafica and Gregorio G. Yrastorza III; be it
