**A RESOLUTION GRANTING AUTHORITY TO THE CITY
MAYOR RICHARD I. GOMEZ TO IDENTIFY AND
IMPLEMENT PROGRAM ITEMS WHICH ARE
APPROPRIATED IN GENERIC TERMS UNDER THE 2019
ANNUAL INVESTMENT PROGRAM (AIP) PROVIDED, THAT
A LIST OF IDENTIFIED AND PROGRAMMED
INFRASTRUCTURE PROJECTS APPROPRIATED IN
GENERIC TERMS FOR A PARTICULAR MONTH BE
SUBMITTED TO THE SANGGUNIANG PANLUNGSOD ON OR
BEFORE THE 15TH DAY OF THE SUCCEEDING MONTH.**

WHEREAS, the Fourteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated August 2, 2018 from the City Mayor Richard I. Gomez relative to the City Development Council (CDC) Resolution No. 14, Series of 2018, entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR RICHARD I. GOMEZ TO IDENTIFY AND IMPLEMENT PROGRAM ITEMS WHICH ARE APPROPRIATED IN GENERIC TERMS (AIP 2019) PROVIDED THAT A LIST OF IDENTIFIED AND PROGRAMMED INFRASTRUCTURE PROJECTS APPROPRIATED IN GENERIC TERMS FOR A PARTICULAR MONTH BE SUBMITTED TO THE HONORABLE SANGGUNIANG PANLUNGSOD ON OR BEFORE THE 15TH DAY OF THE SUCCEEDING MONTH AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME";

WHEREAS, the CDC has passed and approved the aforesaid resolution to promote effective, efficient and economical governance which will redound to the general welfare of the Ormoc City constituents;

WHEREAS, the granting of authority for the City Mayor to identify and implement program items which are appropriated in generic terms (AIP 2019) subject to the condition prescribed thereat, is deemed more practical and convenient process to the city government in order to fast track the implementation of the priority infrastructure projects of the city which are deemed responsive to the present needs and envisioned to propel local economic growth and development;

WHEREAS, this august Body considers the request of the City Development Council as contained in CDC Res. No. 14 to be substantial and reasonable hence, the matter is most deserving of prompt favorable consideration;

WHEREFORE, on motion presented by SP Member Esteban V. Laurente, Chairman, Committee on Infrastructure Development, duly seconded by SP Member Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I.
