**A RESOLUTION APPROVING THE DISMISSAL OF THE

14<sup>TH</sup> SANGGUNIANG PANLUNGSOD OF ORMOC CITY  
ENTITLED: GEIZEL C. MOSENDE AS COMPLAINANT -  
VERSUS- HON. TRECIA CAMAY GERALDEZ AS  
RESPONDENT.**

WHEREAS, the Sangguniang Panlungsod is authorized by law to hear and decide administrative complaints filed against elected barangay officials, with power to impose appropriate sanctions or penalties;

WHEREAS, in the exercise of the power, the Sanggunian took cognizance of the Complaint, docketed as Administrative Case No. 2018-02, filed by Geizel C. Mosende against Respondent Trecia Camay Geraldez of Barangay Camp Downes, Ormoc City;

WHEREAS, during the pre-session caucus of the 14<sup>th</sup> Sanggunian on August 2, 2018, the matter was discussed and the Sanggunian finds merit in the proposal to dismiss the said case on the ground of lack of jurisdiction considering that when the complaint was filed on June 25, 2018, the respondent has not yet assumed her position as barangay kagawad of Barangay Camp Downes, Ormoc City;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee on Good Government & Oversight, severally seconded by SP Members Tomas R. Serafica, Benjamin S. Pongos, Jr., Gregorio G. Yrastorza III, Esteban V. Laurente and Jasper C. Yerro; be it
