**A RESOLUTION APPROVING THE APPLICATIONS FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT
OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE
FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:**

- 1. DAYHAGAN UNITED SMALL FARMERS ASSOCIATION (DUSFA)**
- 2. KILUSANG PAGBABAGO VENDORS ASSOCIATION (KPVA)**

WHEREAS, this august Body was in receipt of applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit:

1. Dayhagan United Small Farmers Association (DUSFA)
2. Kilusang Pagbabago Vendors Association (KPVA)

WHEREAS, Dayhagan United Small Farmers Association (DUSFA) is an association of farmers registered with the Department of Labor and Employment (DOLE) with its objective to assist in the improvement of the barangay by way of farming as well as to serve the need of women as direct beneficiaries of the association. One of the significant accomplishment of DUSFA in CY 2017 was the conduct of a Ten-hectare compact demo of corn hybrid in support of DA-RFO8 through the City Agriculture Office for free inputs hence thus the association was granted a Corn Sheller machine by the DA-RFO8;

WHEREAS, Kilusang Pagbabago Vendors Association (KPVA), is composed of individuals who were victims of Typhoon Yolanda now residing in Tzu Chi Great Love City, Brgy. Liloan Ormoc City. Among their goals is to build a new source of income through sustainable livelihood programs to assist its members in their endeavor to improve their economic conditions. KPVA is also registered by the Department of Labor and Employment (DOLE);

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) - day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the abovementioned applications, find that the same are in order, and the purposes of the sought accreditation is to promote the moral, social and economic development among its members through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by the SP Members Tomas R. Serafica, Gregorio G. Yrastorza III, Benjamin S. Pongos, Jr., Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Esteban V. Laurente and Jasper C. Yerro; be it


