## RESOLUTION NO. 2018-233

A RESOLUTION CONVEYING PROFOUND RECOGNITION AND GRATITUDE TO ALL THE TEACHERS OF ORMOC CITY AS THEY CONSTANTLY FULFILL THEIR NOBLE VOCATION IN PERSISTENTLY CRAFTING AND **EMPOWERING** LEARNERS AMID MODERN DAY CHALLENGES AND ENCOURAGING ALL ACCOMMODATION FACILITIES SUCH AS HOTELS AND LODGING HOUSES AS WELL AS COMMERCIAL AND RETAIL ESTABLISHMENTS TO OFFER DISCOUNTS OR FREEBIES OR SPECIAL PROMOS FOR TEACHERS, OR COME UP WITH SPECIAL "THANK YOU, TEACHER" MERCHANDISE FROM SEPTEMBER 5, 2018 TO OCTOBER 5, 2018 IN CELEBRATION OF THE NATIONAL TEACHERS MONTH AND WORLD TEACHERS DAY 2018.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated August 24, 2018, endorsing the request of Mr. Robert T. Jardin, Senior Educational Program Specialist, DEPED Division Office of Ormoc City requesting for the passage of the necessary Ordinance or Resolution in relation to the 2018 World Teacher's Day Celebration;

WHEREAS, being the frontline missionary of knowledge in the educational system, teachers have an exceptionally significant role in nation-building, most importantly to the critical stages of learners as they likewise permeate higher values and morals to their students that to epitomize the vitality of their selfless vocation and sacrifice in a resolution highly indispensable;

WHEREAS, by virtue of Presidential Proclamation No. 242, the National Teachers Month was institutionalized and that the same shall be celebrated every 5<sup>th</sup> of September until 5<sup>th</sup> of October to coincide with the United Nations Education, Scientific and Cultural Organization (UNESCO) as the "World Teachers' Day" which is on the 5<sup>th</sup> of October;

WHEREAS, local government units (LGUs) should take the lead in "promoting a culture of gratitude to teachers" who can be considered heroes themselves for nurturing the minds of the youth and future leaders of the country as they cultivate knowledge and inspire their students to think creatively, plant the seeds of innovation and change, the key ingredients for our nation to continue to move forward and soar high;

WHEREAS, as provided by Department of Interior and Local Government (DILG) Memorandum Circular No. 2017-106 dated August 22, 2017, City Mayors were enjoined to come up with support activities in promoting the culture of gratitude to the Filipino teachers, such as but not limited to encourage commercial and retail outlets to offer discounts or freebies or special promos for teachers, or come up with special "Thank you, Teacher" merchandise during the month;

WHEREAS, the support of local government units (LGUs) has been an essential element in the success of celebrations and that the Local Government Unit of Ormoc (LGU Ormoc) fully supports the DepEd- Ormoc City Division in the hosting of the 2018 World Teachers Day Celebration;

WHEREAS, pursuant thereto, the LGU-Ormoc would like to encourage accommodation facilities such as hotels and lodging houses as well as commercial and retail establishments in Ormoc City to offer discounts or freebies or special promos for teachers, or come up with special 'Thank you, Teacher" merchandise during the month in support of the activities and programs for the celebration thereof;

WHEREAS, upon close and thorough review, this Sanggunian believes that all sectors of our society and every Ormocanon should pay homage to the teachers and be in unison to the activities to be promulgated by the Department of Education (DepEd) or any concerned agency in highlighting a widespread recognition, awareness and support to the significance of teachers to the development, culture and values of our City, as well as to our nation;
