A RESOLUTION EARNESTLY ENDORSING FOR FUNDING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) UNDER ITS LOCAL GOVERNMENT SUPPORT FUND-ASSISTANCE TO CITIES (LGSF-AC) FOR THE YEAR 2018, THE PROJECT ENTITLEO: 'REVITALIZING UKBAN SPACES
CULTURAL PROMOTION TOWARDS INCLUSIVE ECONOMIC
CULTURAL PROMOTION TOWARDS INCLUSIVE FORMOC DEVELOPMENT (REHABILITATION/IMPROVEMENT OF ORMOC CITY PARKS & PLAZA) PHASE I" IN THE TOTAL AMOUNT OF TWENTY-SEVEN MILLION ONE HUNDRED TWELVE THOUSAND EIGHT HUNDRED **PHILIPPINE** FIFTY-SIX **PESOS** (PHP27,112,856.00), AND AFFIRMING THAT THE PROPOSED PROJECT FOR FUNDING IS PART OF THE DULY APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) AND ANNUAL INVESTMENT PROGRAM (AIP) OF LGU-ORMOC.

WHEREAS, the Fourteenth Sangguniang Panlungsod received an urgent Endorsement from the Office of the City Mayor dated September 11, 2018 requesting for the issuance of a Resolution endorsing a proposed project entitled: Urban Spaces for Socio-Cultural Promotion towards Inclusive "Revitalizing Economic Development" (Phase 1) for the Local Government Support Fund-Assistance to Cities (LGSF-AC) for the year 2018 in the total amount of TWENTY-SEVEN MILLION ONE HUNDRED TWELVE THOUSAND EIGHT HUNDRED FIFTY-SIX PHILIPPINE PESOS (PHP27,112,856.00), and further classifying the same as EXTREMELY URGENT;

WHEREAS, the requested resolution is pursuant to the requirements set under Local Budget Circular (LBC) No. 116 dated January 29, 2018 and LBC No. 116-A which provides for the guidelines on the implementation of the LGSF-AC in the FY 2018 General Appropriations Act (GAA), Republic Act (RA) No. 10964;

WHEREAS, a specification of the components to be funded under the LGSF-AC will cover the following:

Widening and improvement of esplanade
Installation of rainwater catchment system/facility
Installation of lights and lamps

WHEREAS, the subject project aims to redesign the city plaza to better cater to the social and cultural activities of the city, to mitigate the effects of the expected increase in rainfall, to decrease GHG emissions by expanding tree covering and use of energy-saving furniture, and to prevent the disruption of formal and informal economy;

WHEREAS, the abovementioned project for funding is part of the 2017-2020 LDIP, as approved by this Sanggunian on February 8, 2018 through Resolution No. 2018-036, and this Sanggunian fully supports the City Mayor's intention in endorsing the subject project for funding under LGSF-AC;

WHEREAS, the same project is also part of CY 2018 AIP, as approved by this Sanggunian on August 17, 2017 through Resolution No. 2017-179, found under "Support for the Implementation of the LCCAP Ecological and Environment Sustainability Program (AIP)" with Ref-Code: 1000-02-03-005-51;

WHEREAS, upon close and thorough review, this Sanggunian finds that the request is beneficial as it is anchored towards driving local economic growth through sustainable development principles of environmental protection and balanced economic growth, all for the benefit of the constituents of the City of Ormoc and so therefore, most deserving of this august Body's full support, endorsement and affirmative action the same;
