RESOLUTION NO. 2018-245

A RESOLUTION GRANTING OMNIBUS AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN ENTERTAINMENT CONTRACTS, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), FOR THE VARIOUS CELEBRATIONS OF THE ORMOC CHARTER DAY CELEBRATION ON OCTOBER 20, 2018.

WHEREAS, this august Body was in receipt of an extremely urgent request from the Office of the City Mayor, requesting therein for the passage of a resolution granting the City Mayor Richard I. Gomez, authority to enter into and sign the Entertainment Contracts for Various Celebrations of the Ormoc Charter Day on October 20, 2018;

WHEREAS, by virtue of Republic Act No. 179, otherwise known as the Charter of Ormoc City, the City of Ormoc was established which marked the start of its development;

WHEREAS, every 20th day of October each year, Ormoc City celebrates its Charter Day which has then been a long-standing tradition to celebrate the said date with merriment, meaning and significance to provide Ormocanons and visitors alike time to reminisce the City's founding day and boost their camaraderie as a community of peace-loving citizens;

WHEREAS, in the first Contract, the parties have agreed that LGU-Ormoc, the Producer, will engage the services of TRES MARIAS, the Artists, where the latter will perform a live show on October 20, 2018 between 8:00 in the evening and 12:00 midnight at the Ormoc City Plaza in connection with the Ormoc Charter Day celebration, a photocopy of the Entertainment Contract is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, in the second Contract, the parties have agreed that LGU-Ormoc, the Producer, will engage the services of ETHYL C. GABISON a.k.a. ETHEL BOOBA and MARVIN DE LEON MARTINEZ a.k.a. ATE SHAWIE, the Artists, where the latter will perform a live show on October 20, 2018 between 8:00 in the evening and 12:00 midnight at the Ormoc City Plaza in connection with the Ormoc Charter Day celebration, a photocopy of the Entertainment Contract is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, in the third Contract, the parties have agreed that LGU-Ormoc, the Producer, will engage the services of BROWNMAN REVIVAL, the Band, where the latter will perform a live show on October 20, 2018 at 9:00 in the evening at the Ormoc City Plaza in connection with the Ormoc Charter Day celebration, a photocopy of the Entertainment Contract is hereto attached as Annex "C" and made an integral part hereof;

WHEREAS, the parties thereto are committed in collaborating to enter into said contracts with full knowledge, commitment and willingness in the fulfillment of their responsibilities contained thereon;

WHEREAS, the City Legal Officer issued a legal opinion dated September 19, 2018 stating that there is no objection to the draft contracts and finds that the same are within the powers of the City pursuant to Sec. 53.6.1 (a) of the 2016 Revised IRR of RA 9184, and that further, recommends that an omnibus authority from the Sanggunian be requested in cognizance of the probability that the City will host more entertainers in the course of the 2018 Charter Day Celebration, a copy of the said letter is hereto attached as Annex "D" and made an integral part hereof;

WHEREAS, upon close and thorough review, this Sanggunian, finds that the Entertainment Contracts are not contrary to law and existing contracts, and that its aim is for the enjoyment and entertainment of the Ormocanons in celebrating the Ormoc Charter Day;

WHEREFORE, on joint motion of SP Member Gregorio G. Yrastorza, III, Chairman, Committee on Tourism, Cuiture and Arts; and SP Member Nolito M. Quilang, Vice-Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Eusebio Gerardo S. Penserga, Esteban V. Laurente and Jasper Yerro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING OMNIBUS AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ, OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN ENTERTAINMENT CONTRACTS, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), FOR THE VARIOUS CELEBRATIONS OF THE ORMOC CHARTER DAY CELEBRATION ON OCTOBER 20, 2018;

This Agreement made and entered into this 14th day of September, 2018 by and between: SILVIA MALUPEN, Manager of TRES MARIAS with ADDRESS #South Insula Timog, Quezon City, TIN: 484-918-333-000 herein after referred to as the ARTISTS;

HON. RICHARD I. GOMEZ, as Mayor of Ormoc City, Province of Leyte, referred to as the PRODUCER.

WITNESSETH: THAT,

Whereas, the PRODUCER has engaged the services of the ARTISTS for the following show:

NOW, THEREFORE, the ARTISTS and PRODUCER, by these presents, do hereby enter into an Entertainment Contract, whereby the PRODUCER engages the services of the ARTISTS under the following terms and conditions:

- 1. ARTISTS shall be performing a 45minutes live show on October 20, 2018 between 8:00 in the evening and 12:00 midnight at Ormoc City Stage, Ormoc City, Province of Leyte.
- 2. PRODUCER shall pay the ARTISTS a total amount of PESOS: TWO HUNDRED TWENTY THOUSAND PESOS (P220,000.00), NET OF TAX, to be paid in the following manner;
 - a. Producer will pay a down payment of ONE HUNDRED TEN THOUSAND PESOS (P110, 000.00) from the total agreed talent fee of ARTIST in CASH upon signing of contract

- b. The balance of ONE HUNDRED TEN THOUSAND PESOS (P110, 000.00) should be paid in CASH before the ARTISTS performance on the event day.
- 3. PRODUCER shall provide the following for the ARTISTS;
 - a. PRODUCER should provide TWELVE (12) Roundtrip Airfare tickets from Manila-Tacloban-Ormoc and Ormoc-Tacloban-Manila VIA Air Asia for the entire entourage of the ARTISTS, with 160kls baggage allowance. PRODUCER should also provide land transportation for the exclusive use of the ARTIST and its entourage for the entire duration of the ARTISTS' stay.
 - b. PRODUCER should provide Hotel Accommodation (6 ROOMS), for the ARTISTS and its designated assistant for the duration of the said show date.

- c. Meals, snacks and mineral water for artists and designated assistant during the entire duration of the entourage's stay at the place of performance.
- d. ARTISTS and its designated assistant shall be provided with necessary security as well as full legal and medical protection during the entire duration of the said show date.
- e. PRODUCER should provide complete LIGHTS & SOUNDS SYSTEM with based set up based on the TECHNICAL RIDER provided by the ARTISTS.
- 4. The performance can be filmed, audio or video recorded by the Producer/Organizer.
- 5. ARTISTS' participation for promotional purposes, i.e, press conference, Radio/TV appearances, and other similar promotional activities shall be upon mutual consent and agreement.
- 6. PRODUCER and ARTISTS shall bind themselves to the full and proper execution of this contract and shall in no way jeopardize its consummation. PRODUCER shall act at its best capacity to attend and supervise totality of the show production.
- 7. In the event that the PRODUCER cancels the engagement or is unable to perform its obligation under this contract for reasons not attributable to the ARTIST and provided that the reason for the cancellation are not considered fortuitous events nor "Acts of God', the PRODUCER shall forfeit to the ARTIST any and all payments already made.
- 8. If the ARTIST cancels the engagement or is unable to perform its obligation under this contract for reasons not attributable to the PRODUCER, and provide that the reasons for the cancellation are not considered fortuitous, nor "Acts of God', the ARTIST shall be obligated to return whatever payments or deposits already made.
- 9 Should the engagement be cancelled by reasons or as consequence of a fortuitous events or "Acts of God" or other acts though foreseen, cannot be reasonably prevented by the parties, the PRODUCER shall agree to move the date(s) of engagement which shall be agreed upon by both parties, show should be re scheduled only within 190 days from the original show date.
- 10. PRODUCER and ARTIST agree and warrant that they have full understanding of the terms and conditions set forth in this contract. In case any legal suit that may arise out of this contract, the parties hereto agree that the proper Philippines courts shall have jurisdiction over the case and further, that the attorney's fees equivalent to 25% of the amount in dispute shall be added to the cost of the suit as maybe deemed proper by the court.





The undersigned further takes cognizance of the probability that the City will host more entertainers in the course of the 2018 Charter Day celebrations, and recommends that, for the purposes of expedience, that the Mayor request an omnibus authority from the SP to sign entertainment contracts of a similar nature for the 2018 Charter Day celebrations.
