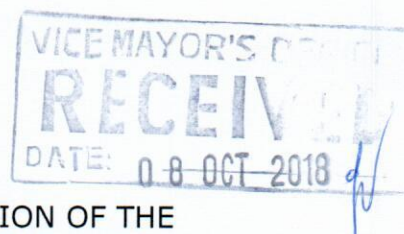

**A RESOLUTION APPROVING THE APPLICATIONS FOR

UNIT OF ORMOC, IN ACCORDANCE WITH THE
PROVISIONS OF ORDINANCE NO. 009 DATED
OCTOBER 16, 2014 OF THE FOLLOWING CIVIL
SOCIETY ORGANIZATIONS, TO WIT:**

- 2. STO. NIÑO VISARES TRANSPORT SERVICE MULTI-
PURPOSE COOPERATIVE (SAVIMCO)**

WHEREAS, this august Body was in receipt of applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit;

1. Leyte Geothermal Employees Multi-Purpose Cooperative (LGECC-MPC)
2. Sto. Niño Visares Transport Service Multi-Purpose Cooperative (SAVIMCO)

WHEREAS, Leyte Geothermal Employees Multi-Purpose Cooperative (LGECC-MPC) is an active partner of LGU in the enhancement and development of the local economy through their active participation in livelihood projects. LGECC-MPC is duly registered under the Cooperative Development Authority (CDA) for the purpose of encouraging thrift and granting loans to members for productive, educational and providential purpose, providing goods and services and other requirements to its members;

WHEREAS, Sto. Niño Visares Transport Service Multi-Purpose Cooperative (SAVIMCO) formerly Sto. Niño Visares Multi-Purpose Cooperative is registered with the Cooperative Development Authority (CDA). Among its purpose is to engage in Credit and Savings, Crop and Animal Production and processing of farmers products as well as farm equipment rental and transportation services to members and non-members;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) - day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the abovementioned applications, find that the same are in order, and the purposes of the sought accreditation is to promote the moral, social and economic development among its members through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by the SP Members Vincent L. Rama, Mario M. Rodriguez, Tomas R. Serafica, Benjamin S. Pongos, Jr., Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar, Esteban V. Laurente and Jasper C. Yerro; be it
