WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated October 15, 2018, requesting therein for the passage of a resolution naming PSSupt. Ramil L. Ramirez as son of Ormoc City in light of his sincere and dedicated service to the people of Ormoc City;

WHEREAS, PSSupt. Ramil Laroga Ramirez was a graduate of Bachelor of Science in Public Safety from the Philippine National Police Academy in 1990, and assumed as the City Director of Ormoc City Police Office last July 01, 2016;

WHEREAS, during his term as the City Director of the Ormoc City Police Office, he brought the Philippine National Police (PNP) closer to the public through information dissemination of PNP activities in the radio program dubbed as "Kapulisan para sa Katawhan" and posting of crime prevention tips in an electronic billboard, sharing its advocacies with wide information and for the community to be vigilant and be aware on how to prevent crimes;

WHEREAS, during that time, he also intensified the campaign against all forms of criminality especially the Anti-Illegal Drugs Campaign that resulted to the reduction of supply and demand of illegal drugs and the reduction of crimes in the City;

WHEREAS, the same has led to Ormoc City being the first City in Region VIII to have been declared as drug cleared, and to the declaration of Ormoc as the safest City in the Philippines in the Year 2016 and 2017;



WHEREAS, to all his gestures of sincere service and assistance, the people of Ormoc hereby expresses their personal gratitude and appreciation for the personal sacrifices and services rendered by the men and women of the Philippine National Police during the leadership of then City Director PSSupt. Ramil L. Ramirez;

WHEREAS, this fourteenth Sanggunian would be eternally grateful, and it would be a source of pride and inspiration for Ormocanons to have an adopted son in the person of PSSupt. Ramil L. Ramirez who is a dynamic leader and a man of honor who swiftly executes his order and mission to effectively deliver public service;

WHEREAS, upon close and thorough review, this Sanggunian finds that naming PSSupt. Ramil L. Ramirez as son of Ormoc, would be a source of pride and honor for the City and Ormocanons in general, so therefore, most deserving of this august Body's full support and affirmative action;
